ORDER: -

In the Notification first read above, the Ministry of Road Transport and Highways, Government of India, New Delhi has issued an amendment to the Central Motor Vehicles Rules, 1989 by inserting rule 167A. Electronic Monitoring and Enforcement of Road Safety after rule 167 of the said Rules.

- 2. As per sub-rule (1) of the said rule 167A of the Central Motor Vehicles Rules, 1989, the electronic enforcement device used for issuance of a challan shall have on approval certificate signed by a designated authority of the State Government certifying that the device is accurate and operating properly and the approval certificate shall be renewed on a yearly basis.
- 3. Based on the Government of India Notification, the Transport Commissioner has sent a proposal to authorize the Police Officers as designated authorities to issue approval certificate.
 - 4. The Government, after careful examination of the said proposal

of the Transport Commissioner have decided to designate the following Police officers as the authorities to certify and sign the approval certificate under the said sub-rule (1) of rule 167A of the Central Motor Vehicles Rules, 1989.

5. Accordingly, under sub-rule (1) of rule 167A of the Central Motor Vehicles Rules, 1989, the Governor of Tamil Nadu hereby designates the Additional Superintendent of Police, Head quarters in the Districts and the Additional Deputy Commissioner of Police, Traffic in the Cities, who are otherwise nominated as the Nodal Officer for Traffic and Road Safety Cell, as the authority to certify and sign the approval certificate certifying that the electronic enforcement device is accurate and operating properly.
