Home Department – Prisons and Correctional Services – Announcement of the Hon'ble Minister for Law during the Prison demand for the year 2023-2024 - Enhancement of Risk Allowance to Prison Executive Staff on par with Police Personnel – Orders – Issued.

ORDER :

In the Government Order first read above, Government enhanced the Risk Allowance to executive staff of Prison Department from the rank of Grade II Warders to Superintendent of Prisons on par with Police Officials as detailed below:-

Grade II Warder to Deputy Jailor : Rs.400/- per month
Jailor to Superintendent of Prison : Rs.450/- per month

2. In the Government Order second read above, Government enhanced the Risk Allowance to executive staff of Prison Department from the rank of Grade II Warders to Superintendent of Prisons as detailed below:-

Grade II Warder to Deputy Jailor : Rs.800/- per month
Jailor to Superintendent of Prison : Rs.900/- per month

3. The Hon'ble Minister for Law, while moving the Demand of the Prisons and Correctional Services for the year 2023-2024 on the Floor of the Assembly on 10.04.2023, has made the following announcement (No.3) among others:

4. Based on the above announcement, the Director-General of Police / Director-General of Prisons & Correctional Services has sent a proposal to Government for sanctioning a sum of Rs.1,00,17,600/- (Rupees One Crore seventeen thousand and six hundred only) for Enhancement of Risk Allowance from the present rate of Rs.800/- to Rs.1000/- per month from Grade II Warders to Deputy Jailors and Rs.900/- to Rs.1000/- from Jailors to Superintendents of Prisons working in this department on par with Police Personnel.

5. The Government after careful examination, have decided to accept the proposal of the Director-General of Police / Director-General of Prisons & Correctional Services, Chennai. Accordingly, the Government direct that the rate of Risk Allowance to the executive staff of Prison Personnel be enhanced as detailed below and also sanction a sum of Rs.83,48,000/- (Rupees Eighty three lakh and forty eight thousand only) for the current financial year 2023-2024:

Post	Existing rate	Enhanced rate
Grade II Warder to Deputy Jailor	Rs.800/-p.m.	Rs.1000/- p.m.
Jailor to Superintendent of Prison	Rs.900/-p.m.	Rs.1000/- p.m.

The details of posts and their respective enhanced rates are given in the annexure to this order. This order shall take effect from date of issue of orders.

6. The above expenditure shall be debited to the following head of account:

(i) Rs.58,42,000/-

"2056-00-Jails-101.Jails - State's Expenditure AA-Jails
(other than Sub Jails) - 301 Salaries - 04 Other allowances

(ii) Rs.25,06,000/-

301 Salaries- 04- Other Allowances

7. The expenditure sanctioned in para 5 above shall constitute an item of "**New Instrument of Service**" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director-General of Police/Director-General of Prisons & Correctional Services is requested to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director-General of Police/Director-General of Prisons & Correctional Services shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2023-2024 to Finance (Home-II/BG-I) Department at an appropriate time without fail.

8. This order issues with the concurrence of Finance Department vide its U.O. No.23233/Home-II/2023, Dated 19.06.2023 and Additional Sanction Ledger No. 309 (Three Hundred and Nine) [IFHRMS ASL No. 2023060309].


