ORDER:

The Hon'ble Chief Minister while replying to the Demand No.22 "Police" for the year 2022-2023 on 10.5.2022 has announced the following:

சென்னை பெருநகரில் பணிபுரியும் காவலர்களின் உடல் நலனை, மென்பொருள் மூலம் கண்காணித்தல்.

பெருநகர காவல், காவலர் மருத்துவமனையில் சென்னை சோதனைக் கூடங்கள் மட்டுமின்றி அனைத்து வகையான சிகிச்சை அளிக்க நோய்களுக்கும் வசதி பொது தற்போது ஆளினர்கள்/ செய்யப்பட்டுள்ளதுடன், காவல் அதிகாரிகளின் வாழ்க்கைத் துணைவியர்க்கும் வருடாந்தர மருத்துவ பரிசோதனை செய்து கொள்கின்றனர். அணைத்தும் தொகுக்கப்பட்டு மருத்துவ பதிவுகள் இந்த மென்பொருளில் நிர்வகிக்கப்படும், இதன்மூலம் காவலர்கள் மற்றும் அவர்களது குடும்ப உறுப்பினர்களின் உடல் நிலையை கிறம்பட கண்காணிக்க இயலும். இதற்கான செலவினம் ரூபாய் 46 இலட்சம்.

- 2. The Director-General of Police / Commissioner of Police, Greater Chennai Police, Chennai, in the letter first read above has stated that the main job of Policemen is to maintain law & order and peace in society; therefore, fitness remains the key factor in their job. Policing is synonymous to working in a challenging and stressful job environment. The various stressors faced by a police personnel include irregular working hours, shift work, duty tours to areas of conflict, away from home for long periods, confronting criminals and dangerous situations, always in a state of alertness even when off duty etc. These stressors affect Police Personnel's life adversely and due to enormous work stress, Police Personnel suffer from different health problems.
- 3. The Director-General of Police / Commissioner of Police, Greater Chennai Police, Chennai, has also stated that to address the need, Police Hospital at Greater Chennai Police was established in 1963 and it is equipped to treat all kinds of common ailments of policemen apart from testing laboratories and annually 1,95,764 Nos. of Police Personnel are visiting the hospital. He has also stated that the Government has approved the Master Health Check-up for all Personnel and extended the said medical facility to the family member also.
- 4. The Director-General of Police / Commissioner of Police, Greater Chennai Police, Chennai, has further stated that at present patient medical services accounting and patient history are not available and retrieval of physical record would be very difficult. Integration with other system such as laboratory, nursing, etc., is a problem. If all these medical records are compiled and managed in software, it would be easy to monitor the health of Policemen and their family members effectively. He has therefore proposed to have a Health Management Software.
- 5. The Director-General of Police / Commissioner of Police, Greater Chennai Police, Chennai, has furnished the rough cost estimates for the proposed Health Management Software as detailed below:-

- 6. The Director-General of Police/Commissioner of Police, Greater Chennai Police, Chennai, has therefore requested the Government to sanction a sum of Rs.45,50,000/- (Rupees Forty five lakhs and fifty thousand only) for the Health Management Software for the Police Personnel working at Chennai.
- 7. The Director-General of Police & Head of Police Force, Tamil Nadu, Chennai, in the letter second read above, has stated that sanction may be accorded for the above proposal.
- 8. The Government examined the proposal of the Director-General of Police/Commissioner of Police, Greater Chennai Police, Chennai, in detail and decided to accept it. Accordingly, the Government accord administrative sanction for a sum of Rs.45,50,000/- (Rupees Forty five lakh fifty thousand only) for development of the Health Management Software for the Police personnel working at Greater Chennai Police.
- 9. The Government also accord financial sanction for a sum of Rs.20,00,000/- (Rupees Twenty lakh only) for software development. The Commissioner of Police is directed to send necessary proposal to Government for release of remaining amount after completion of development of the software.
- 10. The expenditure sanctioned in para 9 above shall be debited to the following head of account.

11. The expenditure sanctioned in para-9 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Commissioner of Police, Chennai is requested to calculate the actual amount required for the period up to next Supplementary Estimate and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Commissioner of Police, Chennai shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimate for the year 2022-2023,to Finance(Home-I/BG-I)Department without fail.
