#### ORDER:

The Registrar General, High Court of Madras, in his letters read above, has stated that the High Court, after considering the request of the Bar Association, Tirukoilur and in consultation with the Principal District Judge, Villupuram has decided to constitute a Sub Court at Tirukoilur (formerly in Villupuram District) in Kallakurichi District. In this regard, he has stated that out of the 6258 cases pending on the file of the existing Sub Courts (Principal, I Additional and II Additional), Villupuram, Chief Judicial Magistrate Court, Villupuram and Special District Court and Sub Courts I and II for trial of MCOP cases, Villupuram as on 29.02.2020, 907 cases including 333 Original Suits, 43 Appeal Suits, 14 CMA/RCA, 311 MCOPs, 33 HMOPs, 124 EPs, 4 IPs and 44 Sessions cases are arising from the territorial jurisdiction of the proposed Sub Court at Tirukoilur (formerly in Villupuram District) in Kallakurichi District. The total number of 333 Original Suits arising from the territorial jurisdiction of Tirukoilur justifies the need for constitution of a Sub Court at Tirukoilur (formerly in Villupuram District) in Kallakurichi District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of a Sub Court at Tirukoilur (formerly in Villupuram District) in Kallakurichi District with requisite posts and other requirements. He has also requested the Government for the attachment of the Copyist Establishment and Nazir Establishment now functioning at the Principal District Munsif Court, Tirukoilur with that of the proposed Sub Court, Tirukoilur to form a Central Nazerath Establishment and a Central Copyist Establishment on the constitution of a Sub Court at Tirukoilur.

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government accord sanction for constitution of a Sub Court at Tirukoilur (formerly in Villupuram District) in Kallakurichi District by sanctioning 19 new posts and other infrastructure facilities at a total expenditure of Rs.1,79,37,664/- (Rupees one crore seventy nine lakh thirty seven thousand six hundred and sixty four only) [viz. Rs.1,62,94,664/- as recurring expenditure and Rs.16,43,000/- as non recurring expenditure] as detailed below:-

- 5. The incumbents of the posts sanctioned in para 3 above are eligible for pay and other allowances as per orders in force.
- 6. The Director of Stationery and Printing, Chennai is directed to supply two Tamil typewriters and two English typewriters, stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.
- 7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

The expenditure sanctioned in para 3 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Registrar General, High Court of Madras is directed to calculate the actual amount required for period up to next Supplementary Estimates and sanction of the same as advance from the Contingency Fund to the Finance (BG-I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Registrar General, High Court of Madras shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023 to Finance (BG-I/Home-II) Department at the appropriate time, without fail.
- 10. This order issues with the concurrence of Finance Department vide its U.O.No.31093/Home-II/2022, dated 24.06.2022, PSL No.202206PSL0199 and Additional Sanction Ledger No.458 (Four hundred and fifty eight).
