



## **ABSTRACT**

Home Department – Prisons and Correctional Services – Announcement of the Hon'ble Minister for Law during the Prison Demand for the year 2023-2024 – Enhancement of Extra Time Remuneration from Rs.200/- to Rs.500/- per day for Prison Warders (Grade – II Warders and Grade I Warders including Vigilance Wing) on par with Police Personnel (Grade –II Police Constables to Head Constables)– Orders – Issued.

### **ORDER :**

In the Government Order first read above, the Government enhanced the Extra Time Remuneration from Rs.150/- to Rs.200/- per day for Prison Personnel on par with Police Department.

2. The Hon'ble Minister for Law, while moving the Demand of the Prisons and Correctional Services for the year 2023-2024 on the Floor of the Assembly on 10.04.2023, has made the following announcement (No.2) among others:-

3. Based on the above announcement, the Director General of Police /Director General of Prisons and Correctional Services has sent a proposal to Government for the enhancement of Extra Time Remuneration to the Prison Warders (i.e., Grade-II Warders, Grade I Warders including Vigilance Wing) to Rs.500/- per day (on par with Police Personnel) in lieu of weekly off due to the introduction of the 8 Hours duty system in Central Prisons / Special Prison for Women / Borstal School, Pudukottai and also to the warders of Sub Jails when they are mobilized to and deployed for security duty in Central Prisons round the clock, during large scale influx of Prisoners on account of mass with financial sanction a sum of Rs.3,24,32,400/- (Rupees Three Crores Twentys Four lakhs Thirty Two thousand and Four hundred only) per annum.

4. The Government after careful examination, have decided to accept the proposal of the Director General of Police /Director General of Prisons and Correctional Services Chennai. Accordingly, the Government enhance the Extra Time Remuneration to the Prison Warders ( i.e., Grade- II Warders and Grade I Warders including Vigilance Wing) on par with Police Personnel (Grade -II Police Constables to Head Constables).

5. The expenditure sanctioned at para 4 above shall be debited to the following Sub-detailed head of account:-

(a) For personnel working in Central Prisons, Special Prison for Women and Borstal School Pudukottai.

6. The expenditure sanctioned in para 4 above shall constitute an item of **“New Instrument of Service”** and the approval of Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund.

The Director General of Police/ Director General of Prisons and Correctional Services is requested to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance(BG.I)Department. The Director General of Police/ Director General of Prisons and Correctional Services shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2023-2024 to Government in Finance (Home-II/ BG-I) Department at an appropriate time without fail.

7. This order issues with the concurrence of Finance Department, vide its U.O.NO.24366/Home-II/2023, dated 27.06.2023 and Additional Sanction Ledger No. 404 (Four Hundred and Four) (IFHRMS ASL No.2023060404).
