ORDER

In the Government order first read above, orders were issued, among others, for sanction of a District Munsif-cum-Judicial Magistrate Court at Watrap in Virudhunagar District with posts and other requirements.

Consequent to the above orders, the Registrar-General, High Court of Madras, has now sent draft notification under sub-section (1) of section 11 of the Code of the Criminal Procedure, 1973 (Central Act 2 of 1974) for the purpose of establishment of a court of Magistrate at Watrap in Virudhunagar District, with a request to publish the same in Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notification shall be published in Tamil Nadu Government Gazette:-
