ORDER:-

In the Government Order first read above, orders were issued for constitution of 13 Family Court in various places including at Tiruvarur in Tiruvarur District and notified in Government Order second read above. Subsequently, the said Family Court was constituted at Mannargudi instead of Tiruvarur by way of amendment in Government Order third read above and notified in Government Order fourth read above. The Family Court at Mannargudi started functioning with effect from 22.11.2019 and the said court exercised jurisdiction over the local limits of Mannargudi Taluk. Further, the Jurisdiction of the Family Court, at Mannargudi was extended to the local limits of Thiruthuraipoondi, Valangaiman and Needamangalam Taluks in Government Order sixth read above.

2. The Registrar General, High Court, Madras in his letter seventh read above has stated that the Government in Government Order fifth read above, have issued orders for creation of a new Taluk namely Koothanallur in Tiruvarur District and the Principal District Judge, Tiruvarur has sent a proposal for extending the jurisdiction of Family Court, at Mannargudi to the newly formed Koothanallur Taluk. Therefore, he has requested the Government to issue orders thereon and to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination, have decided to accept the proposal of the Registrar General, High Court of Madras. Accordingly, the following Notification shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by sub-section (2) of section 3 of the Family Courts Act, 1984 (Central Act 66 of 1984), the Governor of Tamil Nadu, after consultation with the High Court of Madras, hereby increases the jurisdiction of the Family Court, Tiruvarur at Mannargudi to the local limits of Koothanallur Taluk also.
