### ORDER

The Registrar-General, High Court of Madras, in his letter first read above, had stated that after considering the request of the Principal District Judge, Villupuram and considering the pendency of both civil and criminal cases in the existing District Munsif-cum-Judicial Magistrate Court at Vanur, the Hon'ble High Court has recommended for constitution of a separate District Munsif Court at Vanur and a separate Judicial Magistrate Court at Vanur by bifurcating the existing District Munsif-cum-Judicial Magistrate Court, Vanur in Villupuram District.

2. The Registrar-General, High Court of Madras has, therefore, sent a proposal to Government for constitution of separate District Munsif Court at Vanur with sanction of 10 posts by absorption from the existing District Munsif-cum-Judicial Magistrate Court and sanction of 28 new posts by fresh creation. For constitution of separate Judicial Magistrate Court at Vanur, he has proposed for sanction of 10 posts by absorption from the existing District Munsif-cum-Judicial Magistrate Court and sanction of 6 new posts by fresh creation along with other requirements.

3. Meanwhile, the Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3), has made, among others, the following Announcement on the floor of the Legislative Assembly on 10.04.2023:-

“Constitution of separate District Munsif Court and separate Judicial Magistrate Court at Vanur in Villupuram District by bifurcating the existing District Munsif-cum-Judicial Magistrate Court with creation of various posts and other infrastructure facilities”.

4. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government accord sanction for (i) constitution of a separate District Munsif Court at Vanur with 22 posts, i.e., 12 posts by creation and 10 posts through absorption from the existing District Munsif-cum-Judicial Magistrate Court, at Vanur in Villupuram District and (ii) constitution of a separate Judicial Magistrate Court at Vanur in Villupuram District with 15 posts, i.e., 5 posts by creation and 10 posts through absorption from the existing District Munsif-cum-Judicial Magistrate Court, at Vanur in Villupuram District with other requirements at a total expenditure of Rs.1,49,74,610/- (Rupees one crore forty nine lakh seventy four thousand six hundred and ten only) [viz. Rs.1,32,81,610/- as recurring expenditure and Rs.16,93,000/- as non recurring expenditure] as detailed below:-

5. The Government direct that other amenities viz., Furniture, Typewriters, Telephones, Computers, Permanent Advance, Contingencies, Library Books and Stationery articles that were sanctioned to the existing District Munsif-cum-Judicial Magistrate Court, Vanur be utilized for the Judicial Magistrate Court, Vanur.

6. The incumbents of the posts sanctioned in paragraph 4 above are eligible for pay and other allowances as per orders in force.

7. The Director of Stationery and Printing, Chennai is directed to supply other stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

The expenditure sanctioned in paragraph 4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2023-2024. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Registrar-General, High Court of Madras is directed to calculate the actual amount required for the



period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG-I) Department directly in Form 'A' appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Registrar-General, High Court of Madras shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2023-2024 to Finance (BG-I) Department at the appropriate time, without fail.
