### **NOTIFICATION**

In exercise of the powers conferred by section 14 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 (Central Act 33 of 1989), the Governor of Tamil Nadu with the concurrence of the Chief Justice of the High Court, Madras, hereby makes the following amendments to the Home Department Notification No.II (2)/HO/2422/97, published at page 685 of Part II – Section 2 of the <u>Tamil Nadu Government Gazette</u>, dated the 3<sup>rd</sup> December 1997, as subsequently amended:-
