### **ORDER:**

The Honourable Chief Minister of Tamil Nadu has made the following Announcement during the Police Demand for the year 2022-2023 on the floor of Assembly on 10.05.2022.

“13. காவலர் முதல் காவல் ஆய்வாளர் வரையிலானவர்களுக்கு இடர்படியினை ரூ.800-லிருந்து ரூ.1000-ஆகவும் துணை காவல் கண்காணிப்பாளர் மற்றும் கூடுதல் காவல் கண்காணிப்பாளர்களுக்கு ரூ.900-லிருந்து ரூ.1000-ஆகவும் உயர்த்தி கடந்த நிதி ஆண்டில் அறிவிப்பு வெளியிடப்பட்டது. இது காவல் துறையில் உள்ள தொழில்நுட்பப் பிரிவில் பணியாற்றும் அனைத்து ஆளிநர்களுக்கும் வழங்கப்படும்.”

2. Based on the above announcement, the Director General of Police, Chennai in the letter read above has sent the proposal and stated that at present the Risk allowances are given to the Police personnel at various scales depending on the nature of their duties.

3. The Director General of Police has therefore requested the Government to sanction a sum of Rs. 68,29,200/- for Enhancement

of risk allowance of all the Police Personnel in Technical Services wing from the rank of Grade-II Police Constables to Additional Superintendents of Police who are drawing less than Rs.1000/- per month in Tamil Nadu Police Department.

4. After careful examination of the proposal of the Director General of Police, the Government hereby accord Administrative sanction for a sum of Rs.68,29,200/- (Rupees sixty eight lakh twenty nine thousand and two hundred only) and Financial sanction for a sum of Rs.39,84,000/- towards enhancement of Risk Allowance from Rs.200/- to Rs.1,000/- per month for the category of Sub-Inspectors of Police (Technical) to Inspectors of Police (Technical) and from Rs.250/- to Rs.1,000/- per month for Deputy Superintendents of Police / Additional Superintendents of Police (Technical Officers) in Technical Services Wing of Tamil Nadu Police Department.

5. The expenditure sanctioned in paragraph-4 above shall be debited under the following Head of Account:-

2055-00 – Police – 114 Wireless and Computers  
– State's Expenditure – AA Technical Services -  
301 Salaries – 04 Other Allowances.

6. The expenditure sanctioned in paragraph 4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislatures, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director General of Police, Tamil Nadu, Chennai is requested to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG-I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director General of Police, Tamil Nadu, Chennai shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023, to Finance (BG-I/Home-I) Department without fail.
