# **ORDER**

In the Government order first read above, orders were issued for constitution of a Subordinate Judge's Court at Musiri in Tiruchirappalli District with posts and other requirements.

- 2. Pursuant to this, the Registrar-General, High Court of Madras, has now forwarded draft notifications under sections 4, 5 and 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) for the purpose of constitution of a Subordinate Judge's Court at Musiri in Tiruchirappalli District with a request to publish the same in the <u>Tamil Nadu Government Gazette</u>.
- 3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the following Notifications shall be published in the <u>Tamil Nadu Government Gazette Extraordinary:-</u>

#### NOTIFICATION - 1.

In exercise of the powers conferred by the first paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of Subordinate Judges to be appointed under the said Act for Tiruchirappalli District as ten with effect from the date on which the Subordinate Judge, Musiri assumes charge of that Court.

#### NOTIFICATION-II.

In exercise of the powers conferred by the second paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby fixes the number of Subordinate Judges to be appointed for the Subordinate Judge's Courtat Musiri in Tiruchirappalli District as one with effect from the date on which the Subordinate Judge, Musiri assumes charge of that Court.

## NOTIFICATION-III.

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes Musiri in Tiruchirappalli District as the place at which the Subordinate Judge's Court, Musiri shall be held.

# NOTIFICATION-IV.

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby directs that in the District of Tiruchirappalli, the Subordinate Judge's Court at Tiruchirappalli shall cease to have jurisdiction over the District Munsif Court at Musiri and the District Munsif-cum-Judicial Magistrate Court at Thottiam and hereby fixes the local limits of the District Munsif Court at Musiri and the District Munsif-cum-Judicial Magistrate Court at Thottiam as the local limits of jurisdiction of the Subordinate Judge's Court at Musiri with effect from the date on which the Subordinate Judge, Musiri assumes charge of that Court.
