## **ORDER:**

The Hon'ble Chief Minister has made the following announcement among others on 21.04.2023 while replying to the Demand No.22 Police for the year 2023 – 2024.

65. பெருநகர சென்னை காவல்துறையின் ஆயுதப்படை பிரிவில் உள்ள குழந்தைகள் காப்பகத்தில் குழந்தைகளுக்கு நாளொன்றுக்கு வழங்கப்படும் உணவுப்படி ரூ.20-லிருந்து ரூ.40-ஆக உயர்த்தி வழங்கப்படும்.

தற்போது பெருநகர சென்னை காவல்துறையில் உள்ள குழந்தைகள் காப்பகத்தில் பராமரிக்கப்படும் குழந்தைகளுக்கு நாள் ஒன்றுக்கு உணவுப்படியாக ரூ.30/- (அரசு நிதி - ரூ.20 மற்றும் பெற்றோர் நிதி ரூ.10) வழங்கப்பட்டு வருகிறது. குழந்தைகளின் நலன் கருதி ஊட்டச்சத்துமிக்க உணவு வழங்குவதற்கான உணவுப்படி ரூபாய் 60-ஆக (அரசு நிதி - ரூபாய் 40 மற்றும் பெற்றோர் நிதி - ரூபாய் 20) உயர்த்தி வழங்கப்படும்.

2. The Director General of Police in his letter third read above has stated that the Creche in Greater Chennai Police is functioning from 7 AM to 9 PM and about 45 to 50 Children of Police personnel working in

Armed Reserve, Law & Order and Special Units of Greater Chennai Police are utilizing the creche and the children are provided with nutritious food. He has also stated that as per the orders issued in the Government Order first read above Rs. 7.50 was collected from the parents and Rs.7.50 was paid by the Government. Subsequently, the said amount was enhanced to Rs.20/as contribution from the parents and Rs.10/- is being paid by the Government (Total Rs.30/-) towards nourishment charges as per the orders issued in the Government Order second read above. He has further stated that as the prices of groceries, provisions and milk products has increased and that the existing amount of Rs.30/- per child, collected from the parents and paid by the Government is quite inadequate. Hence, there is a need to increase the amount for daily feeding charges for providing nutritious food in accordance with the requirements of the children. He has therefore requested the Government to issue necessary orders to enhance the feeding charges to Rs.60/- per child (Government contribution Rs.40/- and parents contribution Rs.20/-) and to sanction a sum of Rs.4,68,000/- to meet out the additional expenditure.

- 3. The Government examined the proposal of the Director General of Police in detail and accord sanction for enhancement of Government Contribution to Rs.40/- and parents contribution to Rs.20/- per child towards the feeding charges in the creche functioning in the Greater Chennai Police.
- 4. This order issues with the concurrence of Finance department vide its U.O.e.No.1080676/Finance (Home-I) Department, dated 04.08.2023.
