#### **ORDER**

In the Government order first read above, orders were issued, among others, for sanction of a District and Sessions Court at Tenkasi in Tenkasi District with posts and other requirements.

2. Pursuant to this, the Registrar-General, High Court of Madras, has sent draft notifications (i) under sections 3, 4, 5 and 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), (ii) under sections 7(1), 7(2), 9(1) and 11(1) of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974) and (iii) under section 57(1) of the Provincial Insolvency Act, 1920 (Central Act V of 1920) for the purpose of constitution of the District and Sessions Court at Tenkasi in Tenkasi District and publication of the same in the <u>Tamil Nadu Government Gazette</u>.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notifications shall be published in the <u>Tamil Nadu Government Gazette:</u>-

## **NOTIFICATION - I.**

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu hereby establishes a District Court at Tenkasi.

### **NOTIFICATION - II.**

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes the number of District Courts in the cadre of District Judge to be established for Tenkasi District as two and also alters the number of District Courts in the cadre of District Judge for Tirunelveli District as six with effect on and from the date on which the District Judge, Tenkasi assumes charge of that Court.

#### **NOTIFICATION - III.**

In exercise of the powers conferred by section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), and in supersession of all the previous notifications on the subject, the Governor of Tamil Nadu, after consultation with the High Court, Madras hereby fixes the number of Subordinate Judges and District Munsifs for Tirunelveli and Tenkasi Districts, as specified in the Table below, with effect on and from the date on which the District Judge, Tenkasi assumes charge of the District Court at Tenkasi:-

#### **NOTIFICATION - IV.**

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes Tenkasi as the place at which the District Court of Tenkasi shall be held with effect from the date on which the District Judge, Tenkasi assumes charge of that court.

#### **NOTIFICATION - V.**

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) and in supersession of all previous Notifications on the subject, the Governor of Tamil Nadu hereby fixes the local limits of the jurisdiction of the **District Court, Tirunelveli** and **District Court, Tenkasi**, comprising the Revenue Taluks, as specified in the Table below, with effect on and from the date on which the District Judge, Tenkasi assumes charge of the District Court at Tenkasi:-

### **NOTIFICATION - VII.**

In exercise of the powers conferred by sub-section (1) of section 7 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, hereby directs that Tenkasi Sessions Division shall consist of the entire Revenue District of Tenkasi with effect on and from the date on which the District Judge, Tenkasi assumes charge of the Court of Sessions at Tenkasi.

#### **NOTIFICATION - VIII.**

In exercise of the powers conferred by sub-section (2) of section 7 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby alters the limits of the Tirunelveli Sessions Division and defines the limits of the Tenkasi Sessions Division as specified in the Table below, with effect on and from the date on which the Sessions Judge, Tenkasi assumes charge of the Court of Sessions at Tenkasi:-
