### ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the High Court, after considering the request of the Ambattur Bar Association and in consultation with the Principal District Judge, Tiruvallur recommends the proposal for constitution of a Sub Court at Ambattur in Tiruvallur District. In this regard, he has stated that out of the 4494 cases pending on the file of the existing Sub Court, Poonamallee, Tiruvallur as on 28.2.2018, 1569 cases including 640 Original Suits, 116 Civil Regular Appeals, 37 Civil Miscellaneous Appeals and 54 Session Cases are arising from the territorial jurisdiction of the proposed Sub Court, Ambattur in Tiruvallur District. The said number of original suits justifies the necessity for constitution of a Sub Court at Ambattur in Tiruvallur District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for the constitution of a Sub Court, Ambattur in Tiruvallur District with requisite posts and other requirements. He has also requested the Government for the attachment of the existing posts in the Nazerath Establishment and Copyist Establishment sanctioned to the District Munsif Court, Ambattur with that of the proposed Sub Court, Ambattur to form a Central Nazerath Establishment and Central Copyist Establishment on the constitution of a Sub Court at Ambattur.

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, order for the constitution of a Sub Court at Ambattur in Tiruvallur District with the following posts.
