ORDER:

In the Government Order first read above, orders were issued for constitution of a temporary special court presided over by a Sub Judge in Dharmapuri District for the period of six months for disposal of groundnut oil racket and corruption cases filed by the Directorate of Vigilance and Anticorruption, Madras.

- 2. The Registrar General, High Court of Madras, in his letters second read above, has stated that the Principal District Judge, Krishnagiri has requested for conversion of the existing Additional Special Court, Krishnagiri as a Civil Court. He has also stated that there are 499 cases of various categories are pending on the file of the existing Additional Special Court, Krishnagiri as on 31.12.2018.
- 3. The Registrar General, High Court of Madras has also stated that the following posts sanctioned to the Additional Special Court, Krishnagiri are in place as per the Government order and no posts are kept vacant.

- 4. The Registrar General, High Court of Madras has further stated that an accommodation has been allotted to the Additional Special Court, Krishnagiri in the newly constructed Combined Court Building, Krishnagiri with fully equipped furniture for open court, chamber along with Air-Conditioner and office room. He has also stated that sufficient furniture is available in the Additional Special Court, Krishnagiri for use of the proposed Additional Sub Court at Krishnagiri.
- 5. The Registrar General, High Court of Madras has, therefore, requested the Government to issue necessary orders for constitution of an Additional Sub Court at Krishnagiri in Krishnagiri District by converting the existing Additional Special Court, Krishnagiri with the existing posts.
- 6. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government accord sanction for constitution of an Additional Sub Court at Krishnagiri in Krishnagiri District by converting the existing Additional Special Court, Krishnagiri with the following posts already in existence.

The Registrar General, High Court of Madras is directed to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.
