### ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the High Court, after considering the resolution and memorandum of the Bar Association, Aruppukottai and also in consultation with the Principal District and Sessions Judge, Virudhunagar recommends the proposal for constitution of an Additional District Court at Aruppukottai in Virudhunagar District. He has further stated that out of the 2708 cases pending on the file of the existing Principal District Court, Srivilliputhur, II Additional District Court, Srivilliputhur and Additional District Court, Virudhunagar as on 31.08.2020, 417 cases including 80 Original Suits and 121 Appeal Suits are arising from the territorial jurisdiction of the proposed Additional District Court at Aruppukottai in Virudhunagar District. The aforesaid pendency of cases arising from the territorial jurisdiction of Aruppukottai justifies the necessity for constitution of an Additional District Court at Aruppukottai.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of an Additional District Court at Aruppukottai in Virudhunagar District with requisite posts and other requirements. He has also requested that the Copyist Establishment and Nazir Establishment at the Sub Court, Aruppukottai may be attached with that of the proposed Additional District Court, Aruppukottai.

3. During the Budget Session of the Tamil Nadu Legislative Assembly for the year 2021-2022, the Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3) has made, among others, the following Announcement on the floor of the Assembly on 07.09.2021:-

"Constitution of an Additional District Court at Aruppukottai in Virudhunagar District."

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government order for constitution of an Additional District Court at Aruppukottai in Virudhunagar District at a total expenditure of Rs.1,37,29,040/- (Rupees one crore thirty seven lakh twenty nine thousand and forty only) [viz. Rs.1,11,76,040/- as recurring expenditure and Rs.25,53,000/- as non recurring expenditure] by sanctioning the following 15 new posts and other infrastructure facilities.

The Registrar General, High Court of Madras is requested to send necessary draft notification to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court.

9. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Registrar General, High Court of Madras is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the contingency fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Registrar General, High Court of Madras is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022 at the appropriate time without fail.
