### ORDER:

The Registrar General, High Court of Madras, in his letters first and second read above, has stated that the High Court, after considering the request of the Polur Bar Association and in consultation with the District Judge, Tiruvannamalai recommends the proposal for constitution of a Sub Court at Polur in Tiruvannamalai District. He has further stated that out of the 2904 cases pending on the file of the existing Sub Court, Arni as on 31.8.2020, 385 Original Suits, 91 Civil Appeals, 131 EPs, 148 HMOPs, 54 MCOPs, 4 LAOPs and 10 Session cases are arising from the territorial jurisdiction of the proposed Sub Court at Polur in Tiruvannamalai District. The total number of 385 Original Suits arising from the territorial jurisdiction of Polur justifies the need for constitution of a Sub Court at Polur in Tiruvannamalai District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of a Sub Court at Polur in Tiruvannamalai District with requisite posts and other requirements. He has also requested the Government for the attachment of the Copyist Establishment and Nazir Establishment now functioning at the District Munsif Court, Polur with that of the proposed Sub Court, Polur to form a Central Nazerath Establishment and Central Copyist Establishment, on the constitution of a Sub Court at Polur.

3. During the Budget Session of the Tamil Nadu Legislative Assembly for the year 2021-2022, the Hon'ble Minister for Law, while moving the Demand for Grants relating to Administration of Justice (Demand No.3) has made, among others, the following Announcement on the floor of the Assembly on 7.9.2021:-

"Constitution of a Sub Court at Polur in Tiruvannamalai District."

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government order for constitution of a Sub Court at Polur in Tiruvannamalai District at a total expenditure of Rs.1,33,40,352/- (Rupees one crore thirty three lakh forty thousand three hundred and fifty two only) [viz. Rs.1,16,21,852/- as recurring expenditure and Rs.17,18,500/- as non recurring expenditure] by sanctioning 16 new posts and other infrastructure facilities.

6. The Director of Stationery and Printing, Chennai is directed to supply stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

9. The expenditure sanctioned in para 4 above shall constitute an item of "New Instrument of Service" and the approval of Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Registrar General, High Court of Madras is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the contingency fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I / Home-II) Department. The Registrar General, High Court of Madras is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022 at the appropriate time without fail.

10. This order issues with the concurrence of Finance Department vide its C.No.50292/Home-II/2021, dated 15.11.2021, U.O.No. PSL 0036/CMPC/2021, dated 19.11.2021 and Additional Sanction Ledger No.876 (Eight hundred and seventy six).


