ORDER:

The Honourable Chief Minister of Tamil Nadu has made the following announcement during the Police Demand for the year 2020-2021 on the floor of Assembly on 24.03.2020.

“புது டெல்லியில் உள்ள தமிழ்நாடு சிறப்புக் காவல் படை 8-வது அணியில் பணிபுரியும் அனைத்து காவல் அதிகாரிகள்/ஆளினர்கள், அமைச்சுப் பணியாளர்கள், மருத்துவப் பணியாளர்கள் மற்றும் பிற ஊழியர்கள் (சமையலர், முடிதிருத்துவோர், சலவையாளர் மற்றும் துப்புரவு பணியாளர்கள்) அனைவருக்கும் நீலகிரி மாவட்டத்தில் பணிபுரிபவர்களுக்கு வழங்கப்பட்டு வரும் குளிர்காலப் படியைப் போல ஒவ்வொரு வருடமும் நவம்பர் முதல் பிப்ரவரி வரை ஒரு மாத அடிப்படை ஊதியத்தில் 10 விழுக்காடு அல்லது அதிகப்பட்சமாக ரூ.1500/- என 4 மாதங்களுக்கு வழங்கப்படும். இதற்காக அரசுக்கு ஆண்டொன்றுக்கு ரூ.69.18 கோடி செலவாகும்.”

2. Based on the above announcement, the Director General of Police, Tamil Nadu, Chennai, in his letter read above, has stated that, the Tamil Nadu Special Police VIII Battalion, New Delhi Police Officers/personnel including ministerial staff, medical staff and other staff are deputed for the security duty at Tihar Central Jail as per G.O.(Ms)No.1506, Home (Pol-IX) Department, dated 03.11.1998. The winters in New Delhi normally starts from November and peaks in January with lowest temperature ranging between 3°C – 7°C and even plunges to near 0°C. The winter season starts receding by the 3rd week of March. The above mentioned climatic conditions are not conducive to the Tamil Nadu Special Police Personnel, as they are not acclimatized to such cold climate prevailing in Northern India during winter. Moreover, nature of duties performed by Tamil Nadu Special Police Personnel in New Delhi involves both hardship and risk, as they are deployed for Prison Security duty in Tihar Central Jail, Mandoli Central Jail and Rohini Central Jail. Particularly the Police Personnel deployed for outdoor duties such as jail inner moving

duty, high risk ward duty, watch tower duty etc., happens to suffer more during the chilling winters midnight when the temperature falls.

3. The Director General of Police, Chennai has also stated that, the sanctioned strength of the Tamil Nadu Special Police VIII Battalion, New Delhi Viz, Executive Staff, Ministerial staff, Medical Staff and other staff (Cook, Barber, Dhobby, Sweeper) are 1153. The total expenditure required for the sanction of winter allowance for entire strength of 1153 personnel for 4 months at the rate of 10% of their basic pay, subject to maximum of Rs.1500/- per month is worked out to Rs.69,18,000/- (Rupees Sixty nine lakhs and eighteen thousand only) per annum. Hence, the Director General of Police has requested to extend the sanction of Winter Allowance as drawn in the Nilgiris District to the entire strength of Tamil Nadu Special Police VIII Battalion stationed at Tihar Jail and the entire expenditure stated above will be recouped from the Government of National Capital Territory (NCT), New Delhi through the Guard Charges every year. The working sheet is as furnished below:-

Expenditure for a month	1153 X Rs.1500/- = Rs.17,29,500/- p.m.
Expenditure for 4 months	Rs.17,29,500 X 4 months = Rs.69,18,000/-per annum

4. After careful examination of the proposal of the Director General of Police, the Government hereby extend the Winter Allowance to the Police Officers/personnel, Ministerial Staff, Medical Staff and other staff (Cook, Barber, Dhobby, Sweeper) of Tamil Nadu Special Police VIII Battalion, New Delhi at the rate of 10% of their basic pay subject to a maximum of Rs.1,500/- per month for four months from November to February every year with an additional financial commitment of Rs. 69.18 lakhs (Rupees sixty nine lakh eighteen thousand only/-) per annum, and the said expenditure shall be recouped from the Government of National Capital Territory (NCT), New Delhi through the Guard Charges every year. The Director General of Police, Tamil Nadu, Chennai is directed to take necessary action for such recoupment at appropriate time.

5. The expenditure sanctioned in paragraph 4 above shall be debited under the following head of account:-

Winter Allowance:-

"2055 - 00- Police - 104 - Special Police-State's Expenditure
AO - Battalions when stationed outside the State-301
Salaries - 04 Other Allowances

IFHRMS (D.P.Code 2055-00-104-AO-30104)".

6. The Expenditure sanctioned in para-4 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2020-2021. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director General of Police, Chennai is requested to calculate the actual amount required for the period up to next supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG.I) Department. The Director General of Police, Chennai shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2020-2021, without fail.

7. This order issues with the concurrence of the Finance Department vide its U.O.No.45085/Home-I/2020, dated 14.12.2020 with ASL No.1103 (One thousand one hundred and three).
