ORDER:-

In the Government Orders first and second read above orders have been issued granting Risk allowance to the Police personnel at various scales depending on the nature of their duties.

2. The Honourable Chief Minister of Tamil Nadu has made the following Announcement, during the Police Demand for the year 2021-2022, on the floor of Assembly on 13.09.2021.

“காவல் துறையினரின் நலன்களைக் பாதுகாக்க காவலர்களுக்கு வழங்கப்படும் இடர்ப்படி 800/- ரூபாயிலிருந்து 1000/- ஆக உயர்த்தி வழங்கப்படும். இது அனைத்துத் தரப்பினருக்கும் பொருந்தும்”.

3. Based on the Announcement of Hon'ble Chief Minister, the Director General of Police has sent a proposal to Government for sanctioning a sum of Rs.32,13,00,000/- (Rupees Thirty Two Crore Thirteen Lakh only) for enhancement of Risk allowance to the Police personnel from the rank of Grade II Police Constables to Inspectors of Police, Technical Officer and Inspector (Technical)/Sub-Inspector (Technical) of Police Radio Branch Staff and Single Digit Finger Print Bureau personnel in Tamil Nadu Police Department.

4. The Director General of Police has stated that during the current pandemic, the Police Personnel worked tirelessly risking their lives to enforce the lockdowns and regulations announced by the Government. In this process, many Police personnel lost their lives after getting affected by the COVID-19. Considering the risk undertaken by the Police Personnel working as frontline workers in containing the pandemic, it is necessary that the existing risk allowance be increased appropriately.

5. After detailed examination on the proposal of the Director General of Police, the Government hereby accord sanction for a sum of Rs.31,19,50,200/- (Rupees thirty one crore nineteen lakh fifty thousand and two hundred only), towards enhancement of Risk Allowance from Rs.800/- to Rs.1,000/- per month for the category of Police Constables to Inspectors of Police and from Rs.900/- to Rs.1,000/- per month for Deputy Superintendents of Police / Additional Superintendents of Police, in general category alone. The details of posts and their respective enhanced rates are given in the annexure to this order.

6. The expenditure sanctioned in paragraph-5 above shall be debited under the following Head of Account:-

7. The expenditure sanctioned in Para 5 above shall constitute an item of "New Instrument of Service" for which the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2021-2022. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Director General of Police, Tamil Nadu, Chennai, Director of Vigilance and Anti-corruption and Commissioner of Civil Supplies and Consumer protection are directed to calculate the actual amount required for the period up to next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to Finance (BG.I/Home-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the contingency Fund will be issued from Finance (BG.I) Department. The Head of Department concerned shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022, without fail.

8. This order issues with the concurrence of Finance Department vide its U.O.No.51856/Home-I/2021, dated 24.11.2021 and Additional Sanction Ledger No.938 (Nine hundred and thirty eight)
