ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the High Court, after considering the request of the Katpadi Bar Association and in consultation with the Principal District Judge, Vellore recommends the proposal for constitution of a Sub Court at Katpadi in Vellore District. In this regard, the Registrar General, High Court of Madras has stated that out of the 4744 cases pending on the files of the existing Sub Court, Vellore and Additional Sub Court, Vellore as on 30.11.2018, 1740 cases including 804 Original Suits, 35 Appeal Suits, 8 C.M.As, 5 R.C.As, 131 HMOPs, 269 MCOPs, 453 EPs, 15 IPs and 17 Session Cases are arising from the territorial jurisdiction of the proposed Sub Court, Katpadi. The number of 804 Original Suits arising from the territorial jurisdiction of Katpadi justify the necessity for the constitution of a Sub Court at Katpadi in Vellore District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for the constitution of a Sub Court at Katpadi in Vellore District with requisite posts and other requirements. He has also requested the Government for the attachment of the existing posts in the Nazerath Establishment and Copyist Establishment sanctioned to the District Munsif Court, Katpadi with that of the proposed Sub Court, Katpadi to form a Central Nazerath Establishment and Central Copyist Establishment on the constitution of a Sub Court at Katpadi.

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government order for the constitution of a Sub Court at Katpadi in Vellore District with the following posts.

4. The incumbents of the posts sanctioned in para-3 above are eligible to draw pay and allowances as per orders in force.

5. The Government also order that the following posts in the Nazerath Establishment and Copyist Establishment sanctioned to the District Munsif Court, Katpadi be attached with that of the newly sanctioned Sub Court, Katpadi to form a Central Nazerath Establishment and Central Copyist Establishment on the constitution of the Sub Court at Katpadi:-

6. The Director of Stationery and Printing, Chennai is directed to supply Two Tamil Typewriters and Two English Typewriters, stationery articles, requisite forms and registers to the newly sanctioned Sub Court at Katpadi in Vellore District at free of cost against the specific indent of the Judicial officer concerned.

7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

8. The expenditure sanctioned in paras 3 and 5 above shall be debited to the following heads of account:-

9. The expenditure sanctioned in paragraphs 3 and 5 above shall constitute an item of "New instrument of Service" and approval of the Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Registrar General, High Court of Madras is requested to calculate the actual amount required for the period up to next supplementary estimates and apply for sanction of the same as advance from the contingency fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued by the Finance (BG-I) Department. The Registrar General, High Court of Madras is also requested to send necessary draft explanatory notes to the Government in the Finance (BG-I/Home-II) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2019-2020 at the appropriate time without fail.

10. This order issues with the concurrence of Finance Department vide its C.No.64055/Home-II/2019, dated 6.1.2020, U.O.No.1875/CMPC/2020, dated 10.01.2020 and Additional Sanction Ledger No.2738 (Two thousand seven hundred and thirty eight).


