## ORDER

In the Government Order first read above, orders were issued, among others, for constitution of the District Munsif-cum-Judicial Magistrate Court at Karambakkudi in Pudukkottai District with posts and other requirements.

- 2. Consequent to the above orders, the Registrar General, High Court of Madras, has now sent draft notification under section 11(1) of the Code of the Criminal Procedure, 1973 (Central Act 2 of 1974) for the purpose of establishment of a court of Judicial Magistrate at Karambakkudi in Pudukkottai District, with a request to publish the same in the Tamil Nadu Government Gazette.
- 3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the following Notification shall be published in the TamilNadu Government Gazette:-

## **NOTIFICATION**

In exercise of the powers conferred by sub-section (1) of section

11 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby establishes a Court of Judicial Magistrate at Karambakkudi in Pudukkottai District.
