ORDER:-

The Additional Chief Secretary / Transport Commissioner in his letter read above has stated that Tvl. Tamil Nadu All Omni Bus Owners & Operators Association, Chennai have requested for extension of grace period for the payment of Tax for the First Quarter (01/04/2021 to 30.06.2021) without penalty upto 30.06.2021 due to financial crisis from Covid-19 Pandemic situation. Since, many representations were being received in this connection. He has also sent a copy of Government Orders issued by the Government of Andhra Pradesh in the similar issues.

2. He has, therefore, requested to issue orders extending the last date due for the payment of all transport vehicles tax without penalty upto 30.06.2021 instead of 14.05.2021 for the First Quarter (01/04/2021 to 30.06.2021) in the interest of public, due to Covid-19 Pandemic situation.

3. The Industries and Commercial Associations meeting held under the Chairmanship of the Hon'ble Chief Minister on 09.05.2021 discussed about the execution of the full lockdown due to control the Covid-19 pandemic situation. During the meeting the Hon'ble Chief Minister has announced among others to extend the grace period for payment of Motor Vehicle taxes towards all Auto rickshaws and Taxies plying in the State of Tamil Nadu upto three months without penalty.

4. The Government after careful examination have decided to accept the proposal of the Additional Chief Secretary/Transport Commissioner and accordingly the Government extend the last date for the payment of all transport vehicles tax without penalty upto 30.06.2021 instead of 14.05.2021 for the First Quarter (01/04/2021 to 30.06.2021) in the interest of public, due to Covid-19 Pandemic situation as done in the earlier year.

5. This order issues with the concurrence of Finance Department vide its U.O. No.1486/FS/P/2021, dated 11.05.2021.
