Fire and Rescue Services Department – Announcement made by the Hon'ble Chief Minister - Up-gradation of Hosur, Tambaram, Ranipet Fire and Rescue Services Stations – Sanctioned – Orders issued.

#### ORDER:-

While replying to the Demand No.23 relating to the Fire and Rescue Services Department on 10.05.2022, the Hon'ble Chief Minister of Tamil Nadu has made the following announcement on the floor of the Tamil Nadu Legislative Assembly:-

“கிருஷ்ணகிரி மாவட்டம் ஓசூர், செங்கல்பட்டு மாவட்டம் தாம்பரம், மற்றும் இராணிப்பேட்டை மாவட்டம் இராணிப்பேட்டை ஆகிய தீயணைப்பு மற்றும் மீட்பு பணி நிலையங்கள் ரூபாய் 4.35 கோடி செலவில் மேம்படுத்தப்படும்.”

2. Based on the announcement of the Hon'ble Chief Minister, in the letters second read above the Director General of Police / Director, Fire and Rescue Services has sent the proposal for up-gradation of Hosur Fire and Rescue Services Station in Krishnagiri District, Tambaram Fire and Rescue Services Station in Chengalpattu Revenue District (Chennai South-Fire and Rescue Services District) and Ranipet Fire and Rescue Services Station in Ranipet District at a total cost of Rs.4.35 crore.

3. The Director General of Police / Director, Fire and Rescue Services has stated that Hosur, Tambaram and Ranipet Fire and Rescue Services Stations were opened long back. During the course of time, these cities have grown bigger and some of them have become Corporations. The above said stations are functioning with a single vehicle and with uniform sanctioned strength of 17 personnel. These stations have not been sanctioned with additional firefighting vehicles and are

struggling to attend hundreds of calls with the sanctioned strength of one vehicle.

4. The Director General of Police / Director, Fire and Rescue Services has further stated that there is an all-round economic development of these areas, correspondingly, the firefighting and rescue capability of these areas should be adequately strengthened. Considering the population growth, rapid industrialization, increase in number of factories, malls, petrol bunk and hutments and the fire hazard in all these cities and to achieve quick and more effective fire fighting, it is imperative to upgrade the Fire and Rescue Services Station in these places. For the aforesaid reasons, the above said stations are to be upgraded with the additional sanction of three water bowser with requisite strength of Fire and Rescue Services personnel. The Director has informed that new vehicles will be procured and put in to use in due course of time. Considering the importance of immediate upgrading the fire fighting facilities of these cities, reserve water lorry / water bowzers from other stations / districts are identified for deployment in these stations and the up-gradation may be effected once requisite government orders are issued and furnished the details of required additional strength of Fire and Rescue Services personnel, as below:-

- For **\*Ranipet** Fire and Rescue Services station, the sanctioned strength of Firemen is 11+2. The additional strength of 2 firemen is due to the sanction of Ambulance to this station. The Ambulance meant for this station is condemned and is not replaced with new Ambulance. Now, the Government decided to withdraw the Ambulance services from the purview of the Tamil Nadu Fire and Rescue Services Department after the inauguration of 108 (EMRI) Ambulance Services in this State. Hence, for this station alone, 6 additional firemen strength is required after adjusting the excess strength from the available strength of this station.

5. The Director, Fire and Rescue Services has therefore requested to accord sanction for the following:-

- To sanction the strength for up-gradation at the rate of 2 Leading Firemen, 2 Driver Mechanics and 8 Firemen for Hosur and

Tambaram Fire and Rescue Services stations and 2 Leading Firemen, 2 Driver Mechanics and 6 Firemen for Ranipet Fire and Rescue Services Station. In all, to accord sanction for the total strength of 6 leading fireman, 6 Driver Mechanics and 22 fireman for these three Fire and Rescue stations at a total recurring cost of Rs.1.51 crore.

- ii. To sanction a water bowzer with certain basic firefighting equipment like firefighting hoses-20, hand controlled branch pipe-1, personal protective equipment-6, Battery operated combi-tool-1, Power saw-1, snake catcher-2 and Self-contained Breathing Apparatus sets-2 as additional sanction for each of these stations and in all to accord sanction for three water bowzers with these equipment at a total non-recurring cost of Rs.2.82 crore.

6. The Government, after careful examination of the proposal of the Director, Fire and Rescue Services, Chennai have decided to accept it. Accordingly, the Government accord sanction for a sum of Rs.2,51,31,360/- (Rupees two crore fifty one lakh thirty one thousand three hundred and sixty only) towards staff cost for up-gradation of Hosur Fire and Rescue Services Station in Krishnagiri District, Tambaram Fire and Rescue Services Station in Chengalpattu Revenue District (Chennai South-Fire and Rescue Services District) and Ranipet Fire and Rescue Services Station in Ranipet District, as below:-

7. The Director General of Police/ Director, Fire and Rescue Services is directed to seek funds from the State Disaster Relief Fund (SDRF) for the purchase of 3 (three) water bowzers along with necessary supporting equipments for the three Fire and Rescue Services Stations at Hosur, Tambaram and Ranipet.

8. The expenditure sanctioned in paragraph-6 above shall be debited to the following head of account, Pay and other allowances of the incumbents of the above sanctioned posts shall be booked under the respective detailed / sub detailed heads of account:-

9. The expenditure sanctioned in para-6 above shall constitute an item of "New Instrument of Service" and the approval of the Legislature shall be obtained in due course of time by an inclusion in the Supplementary Estimates 2022-2023. Pending approval of the Legislature, the expenditure may be initially met by drawl of an advance from the Contingency Fund. The Director General of Police / Director, Fire and Rescue Services Department is requested to calculate the actual amount required for the period up to next supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly in Form "A" appended to the Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Director General of Police / Director, Fire and Rescue Services shall also send necessary draft explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2022-2023 the Finance (BG.I/Home-II) Department at an appropriate time without fail.

This order issues with the concurrence of Finance Department vide its U.No.E-920716/Home-II/2022, dated 04.02.2023 and U.O.No.E-920716/CMPC/2022, dated 04.02.2023 with Additional Sanction Ledger No.2273 (Two thousand two hundred and seventy three) and PSL No.202301PSL0014 (IFHRMS ASL No.2023012273).
