#### ORDER: -

In the Government order first read above, the Government have issued notification inviting objections or suggestions on the amendment to be made to rule 132 of the Tamil Nadu Motor Vehicles Rules, 1989, for enhancement of various categories of fees. The same was published in the Home Department Notification No.SROB-43/2022 at page 82 of Part.III-Section 1(b) of the <u>Tamil Nadu Government Gazette</u> dated 17<sup>th</sup> August 2022.

2. The Secretary, Transport Labour Association, Dharmapuri has raised objection on the above draft amendment. The Government after careful examination, have decided to overrule the above objection since the post pandemic situation in Transport and other fields has gradually improved and steadily growing up in all spheres of business on the whole. Moreover, the revision of fees was lastly done during the year 1999 and has not been revised for the past 23 years.

- 3. The Transport Commissioner has stated that the prescription of fee for **Temporary Registration or Extension of Validity of Temporary Registration** had already been prescribed in Table-4A under Rule 81 of the Central Motor Vehicles Rules, 1989, and therefore requested to modify the draft amendment by deleting SI.No.2 of the Table Under rule 132 of the Tamil Nadu Motor Vehicles Rules, 1989.
- 4. The Government accept the proposal of the Transport Commissioner and delete Sl. No. 2 under the Table in the draft amendment to rule 132 of the Tamil Nadu Motor Vehicles Rules, 1989 and confirm the draft amendment issued in the Government Order first read above.

#### NOTIFICATION.

In exercise of the powers conferred by section 65 of the Motor Vehicles Act, 1988 (Central Act 59 of 1988), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Motor Vehicles Rules, 1989, the draft of the same having been previously published, as required under sub-section (1) of section 212 of the said Act.

#### AMENDMENTS.

In the said Rules, in rule 132, in the TABLE.-

- (1) Serial number 2 in column (1) and the corresponding entries in columns (2), (3) and (4) thereof shall be omitted;
- (2) for serial numbers 3,4,5,6,7,9,10,11 and 12 in column (1) and the corresponding entries in columns (2) and (3) thereof, the following serial numbers and the entries shall, respectively, be substituted, namely: -

"3.	For grant of permission for certificate of fitness in other region.	500
4.	For revocation of CFX Notice.	500
5.	For issue of Duplicate Certificate of Fitness.	250
6.	For appeal against the order of Registering Authority or Motor	500
7.	Vehicle Inspector. For issue of certified copy of documents.	400
9.	For the grant of authorization.	5000
10.	For the renewal of authorization.	3000

11. For the late application for renewal of a calendar month.

12. For appeal against the orders of the Transport Commissioner.
