ORDER:

The Registrar General, High Court of Madras, in his letters read above, has stated that the High Court, after considering the request of the Bar Association, Ambur and the Ambur Advocates' Association and in consultation with the Principal District Judge, Vellore recommends the proposal for constitution of a Sub Court at Ambur in Vellore District (now in Tirupattur District). He has further stated that as on 31.12.2018, there are 754 cases including 210 Original Suits arising out of the jurisdiction of the proposed Sub Court, Ambur. The aforesaid pendency justifies the need for the constitution of a Sub Court at Ambur in Vellore District (now in Tirupattur District).

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for the constitution of a Sub Court at Ambur in Vellore District (now in Tirupattur District) with requisite posts and other requirements. He has also requested the Government to issue orders for the attachment of the Copyist Establishment and Nazareth Establishment now functioning in the Principal District Munsif Court, Ambur and the Additional District Munsif-cum-Judicial Magistrate Court, Ambur with that of the proposed Sub Court, Ambur to form a Central Nazerath Establishment and Central Copyist Establishment on constitution of Sub Court at Ambur in Vellore District (now in Tirupattur District).

3. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government order for constitution of a Sub Court at Ambur in Vellore District (now in Tirupattur) at a total expenditure of Rs.1,30,19,749/- (Rupees one crore thirty lakh nineteen thousand seven hundred and forty nine only) [viz. Rs.1,13,01,749/- as recurring expenditure and Rs.17,18,000/- as non recurring expenditure] by sanctioning 16 new posts and other infrastructure facilities.

5. The Director of Stationery and Printing, Chennai is directed to supply two Tamil typewriters and two English typewriters, stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

6. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Registrar General, High Court is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2021-2022 at the appropriate time without fail.


