The following Notification will be published in the Tamil Nadu Government <u>Gazette:</u>

NOTIFICATION.

In exercise of the powers conferred by sections 17-C, 17-D, 17-E, 18-B, 18-C, 20 and 21 read with section 54 of the Tamil Nadu Prohibition Act, 1937 (Tamil Nadu Act X of 1937), the Governor of Tamil Nadu, hereby makes the following amendments to the Tamil Nadu Liquor (Licence and Permit) Rules, 1981.

2. The amendments hereby made shall come into force on and from the 1^{st} April 2019.

AMENDMENTS.

In the said Rules, in rule 17, in sub-rule (b),-

- (i) in clause II, for the expression "an annual privilege fee of Rs.10,00,000/- (Rupees ten lakhs only) for Chennai City and Rs.6,00,000/- (Rupees six lakhs only) for the other areas, a licence fee of Rs.10,000/- (Rupees ten thousand only) and an application fee of Rs.3,000/- (Rupees three thousand only)", the expression "an annual privilege fee of Rs.12,00,000/- (Rupees twelve lakhs only) for Chennai City and Rs.8,00,000/- (Rupees eight lakhs only) for the other areas, a licence fee of Rs.25,000/- (Rupees twenty five thousand only) and an application fee of Rs.7,500/- (Rupees seven thousand and five hundred only)" shall be substituted.
- (ii) in clause III, for the first and second tables, the following tables shall, respectively, be substituted, namely:-
