### ORDER:-

The Hon'ble Minister for Law, Courts and Prisons, while moving the Demand for Grants relating to Administration of Justice (Demand No.3), has made, among others, the following Announcement on the Floor of the Assembly on 20.3.2020:-

"Constitution of five new District Munsif-cum-Judicial Magistrate Courts at Nallampalli in Dharmapuri District, Srimushnam in Cuddalore District, Thiruvannainallur in Villupuram District, Natrampalli in Tirupathur District and Mohanur in Namakkal District".

2. Based on the above Announcement, the Registrar General, High Court of Madras has sent proposal stating that the High Court, after considering the above Announcement, recommends for constitution of a District Munsif-cum-Judicial Magistrate Court at Thiruvannainallur in Villupuram District. In this regard, he has stated that among the total number of 1882 civil cases pending on the files of the existing Principal District Munsif Court, Tirukoilur and I & II Additional District Munsif Courts, Tirukoilur, 178 cases are arising from the territorial jurisdiction of Thiruvannainallur Taluk. Further, out of the total number of 5704 criminal cases pending before the files of the Judicial Magistrate Court No.II, Ulundurpet, 2852 cases are arising from the territorial jurisdiction of Thiruvannainallur Taluk.

3. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of a District Munsif-cum-Judicial Magistrate Court at Thiruvannainallur in Villupuram District with requisite posts and other requirements.

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras, have decided to accept it. Accordingly, the Government order for constitution of a District Munsif-cum-Judicial Magistrate Court at Thiruvannainallur in Villupuram District at total cost of Rs.1,36,84,108/- (Rupees one crore thirty six lakh eighty four thousand one hundred and eight only) (i.e. Rs. 1,20,15,608/- as recurring expenditure and Rs. 16,68,500/- as non recurring expenditure) by sanctioning the following posts and other infrastructure facilities.

5. The incumbents of the posts sanctioned in para 4 above are eligible for pay and other allowances as per orders in force.

6. The Director of Stationery and Printing, Chennai is requested to supply two Tamil Typewriters and two English Typewriters and other stationery items at free of cost for the proposed constitution of the District Munsif-cum-Judicial Magistrate Court at Thiruvannainallur in Villupuram District.

8. The expenditure sanctioned in para 4 above shall constitute an item of "New instrument of Service" and the approval of the Legislature shall be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the contingency fund. The Registrar General, High Court is directed to calculate the actual amount required for the period up to next supplementary estimates and apply for sanction of the same as advance from the contingency fund to the Finance (BG-I) Department directly in Form 'A' appended to the Tamil Nadu Contingency Fund Rules, 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG-I) Department. The Registrar General, High Court is also directed to send necessary explanatory notes to the Government in Finance(Home-II/BG-I) Department for inclusion of this expenditure in the Supplementary Estimates for the year 2020-2021 at the appropriate time without fail.

9. The Registrar General, High Court of Madras is directed to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] and Code of Criminal Procedure 1973 for the commencement of the above said court.

10. This order issues with the concurrence of Finance Department vide its C.No. 2531/Home-II/2021, dated 25.01.2021 and U.O.No. 5191/CMPC/2021, dated 02.02.2021 with Additional Sanction Ledger No.1595 (One thousand five hundred ninety five).


