



## **ABSTRACT**

Courts – Civil and Criminal – Tirupathur and Ranipet District – Constitution of a District and Sessions Court at Tirupathur by converting existing Additional District Court, Tirupathur and constitution of a District and Sessions Court at Ranipet – Publication of Notifications under the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) and the Code of Criminal Procedure, 1973 (Central Act 2 of 1974) – Orders – Issued.

## **ORDER**

In the Government order first and second read above, orders were issued, among others, for sanction and constitution of a District and Sessions Court at Tirupathur by converting existing Additional District Court, Tirupathur and a District and Sessions Court at Ranipet with posts and other requirements respectively.

2. Pursuant to this, the Registrar-General, High Court of Madras, Chennai, has sent draft notifications (i) under sections 3, 4, 5 and 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), (ii) under sections 7 (1), 7 (2), 9 (1) and 11 (1) of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974) and (iii) under section 57(1) of the Provincial Insolvency Act, 1920 (Central Act V of 1920), for the purpose of constitution of the District and Sessions Courts at Tirupathur in Tirupathur District and Ranipet in Ranipet District with a request to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notifications shall be published in the Tamil Nadu Government Gazette:-

**NOTIFICATION – I.**

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu hereby establishes a District Court at Ranipet, and establishes a District Court at Tirupathur by converting the existing Additional District Court at Tirupathur.

**NOTIFICATION – II.**

In exercise of the powers conferred by section 3 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes the number of District Courts in the cadre of District Judge to be established for Ranipet District as two and for Tirupathur District as one and also alters the number of District Courts in the cadre of District Judge for Vellore District as five with effect from the date on which the District Judge, Ranipet and District Judge, Tirupathur assume charge of the respective Courts.

**NOTIFICATION – III.**

In exercise of the powers conferred by section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), and in supersession of all the previous notifications on the subject, the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby fixes the number of Subordinate Judges and District Munsifs for Vellore, Ranipet and Tirupathur Districts, as specified in the Table below, with effect from the date on which the District Judge, Ranipet and District Judge, Tirupathur assume charge of the respective Courts :-

**NOTIFICATION – IV.**

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes Ranipet as the place at which the District Court of Ranipet shall be held with effect from the date on which the District Judge, Ranipet assumes charge of that Court.

**NOTIFICATION – V.**

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby fixes Tirupathur as the place at which the District Court of Tirupathur shall be held with effect from the date on which the District Judge, Tirupathur assumes charge of that Court.

**NOTIFICATION – VI.**

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) and in supersession of all previous Notifications on the subject, the Governor of Tamil Nadu hereby fixes the local limits of the jurisdiction of the District Courts, Vellore, Ranipet and Tirupathur, comprising the revenue taluks, as specified in the Table below, with effect from the date on which the District Judge, Ranipet and District Judge, Tirupathur assume charge of the respective Courts :-

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) and in supersession of all previous notifications on the subject, the Governor of Tamil Nadu hereby fixes the local limits of the Subordinate Judge's Courts of Vellore, Ranipet and Tirupathur Districts, as specified in the Table below, with effect from the date on which the District Judge, Ranipet and District Judge, Tirupathur assume charge of the respective Courts :-

**NOTIFICATION – VIII.**

In exercise of the powers conferred by sub-section (1) of section 7 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, hereby directs that Ranipet Sessions Division shall consist of the entire Revenue District of Ranipet and Tirupathur Sessions Division shall consist of entire Revenue District of Tirupathur with effect from the date on which the District Judge, Ranipet and District Judge, Tirupathur assume charge of the respective Courts.

**NOTIFICATION – IX.**

In exercise of the powers conferred by sub-section (2) of section 7 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby alters the limits of the Vellore Sessions Division and defines the limits of the Ranipet Sessions Division and Tirupathur Sessions Division as specified in the Table below, with effect from the date on which the Sessions Judge, Ranipet and Sessions Judge, Tirupathur assume charge of the respective Courts :-

**NOTIFICATION – X.**

In exercise of the powers conferred by sub-section (1) of section 9 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, hereby establishes a Court of Sessions for the Ranipet Sessions Division and a Court of Sessions for the Tirupathur Sessions Division with effect from the date on which the Sessions Judge, Ranipet and Sessions Judge, Tirupathur assume charge of the respective Courts.

**NOTIFICATION – XI.**

In exercise of the powers conferred by sub-section (1) of section 57 of the Provincial Insolvency Act, 1920 (Central Act V of 1920), the Governor of Tamil Nadu, hereby appoints the present Official Receiver, Vellore District as the Official Receiver for Ranipet District and Tirupathur District also until the appointment of a separate Official Receiver for Ranipet District and Tirupathur District.
