## **ORDER**

In the Government order first read above, orders were issued, among others, for sanction and constitution of a Chief Judicial Magistrate Court, each at Ranipet in Ranipet District and Tirupathur in Tirupathur District with posts and other requirements.

Consequent to the above orders, the Registrar-General, High Court of Madras, has now sent draft notifications under section 11 (1) of the Code of the Criminal Procedure, 1973 (Central Act 2 of 1974) for the purpose of establishment of a Court of Judicial Magistrate at Ranipet in Ranipet District and Tirupathur in Tirupathur District, with a request to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the Government direct that the following Notification shall be published in the Tamil Nadu Government Gazette:-
