ORDER:

The Hon'ble Chief Minister of Tamil Nadu has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly during the Police Demand [Demand No.22] on 10.5.2022:-

“தீயணைப்புத் துறை மற்றும் சிறைத்துறை பணியாளர்களுக்கு காவல் துறை மருத்துவமனைகளில் மருத்துவம் பார்க்கும் வசதி ஏற்படுத்தித் தரப்படும்.

தமிழ்நாட்டிலுள்ள காவல் மருத்துவமனைகளில் காவல் ஆளிநர்களுக்கும்/ அமைச்சுப் பணியாளர்களுக்கும் தரமான மருத்துவ வசதி வழங்கப்பட்டு வருகிறது. இவ்வசதியினை தீயணைப்பு மற்றும் மீட்புப் பணிகள் துறை மற்றும் சிறைத்துறை பணியாளர்களுக்கும் விரிவுபடுத்தப்படும்.

இதன் மூலம் இவ்விரு துறையின் பணியாளர்களுக்கும் தரமான மருத்துவ சேவை கிடைக்கும் வாய்ப்பு ஏற்படும்."

2. The Director General of Police and Head of Police Force in his letter first read above, has stated that in Tamil Nadu there are 12 Police Hospitals functioning in the following locations and requested to extend the Tamil Nadu Police Hospital Treatment Facilities to the Employees in Prison and Fire & Rescue Services Departments as it is available for Police Personnel:-

3. The Director of Medical and Rural Health Services in his letter, second read above, has among others stated that the infrastructure, additional Building, Equipments and additional beds if it is required, have also to be provided according to the strength of the nearby Prison and Fire & Rescue Services Departments. Further he has requested to create following additional staff per Police Hospital, at a cost of Rs. 6,96,14,496/- as follows:-

The Director of Medical and Rural Health Services has further stated that the Home Department may issue necessary orders for the sanction of posts as detailed above, then the posts can be filled up by that Department through Medical Recruitment Board and there is no possibility for deputing staff from the Hospitals under the control of Directorate, since there is already dearth of staff in all categories.

4. The Government after careful examination have decided to accept the proposal of the Director General of Police and Head of Police force and to accord sanction to extend the treatment facilities in Tamil Nadu Police Hospital to the employees in Prison and Fire & Rescue Services Departments as available for Police Personnel subject to the condition that there shall be no request for additional beds or staff and only the additional cost of consumables (Medicine, Instruments) can be provided under the budget.
