### **ORDER:-**

The Hon'ble Chief Minister of Tamil Nadu has made the following Announcement on the floor of the Tamil Nadu Legislative Assembly while replying to the demand for grant for Police Department [Demand No.22], on 21.04.2023:-

2. Pursuant to the above announcement, the Director General of Police/Head of Police Force, Chennai has sent the proposal for annexation of Attayampatti Police Station and Karipatti Police Station of Salem District with Salem City, for better policing to strengthen public order, security and for smooth handling of Law and Order issues. The Director General of Police/Head of Police Force, Chennai has suggested to attach the Attayampatti Police station with existing Kondalampatti Range and to attach the Karipatti Police Station with existing Ammapet Range of Salem City for administrative convenience.

3. The Government after careful examination have decided to accept the proposal of the Director General of Police/Head of Police Force, Chennai. Accordingly, the Government direct that Attayampatti Police Station and Karipatti Police Station of Salem District be annexed with Salem City. Further, consequent to the said annexation, the Attayampatti Police Station will come under the Kodalampatti Range of Salem City and the Karipatti Police Station will come under the Ammapet Range of Salem City.

4. The Government also direct that the Commissioner of Treasuries and Accounts, Chennai to effect the remapping of Drawing and Disbursing Officers Code in IFHRMS portal consequent on the annexation of Attayampatti police station and Karipatti police station of Salem District police with Salem City. The Government also direct that the Commissioner of Police, Salem City shall address the Commissioner of Treasuries and Accounts, Chennai along with copy of this order and the details of the posts to be remapped, with Post Code, present DDO Code and DDO code to which to be remapped so as to complete the remapping in IFHRMS portal.

### **NOTIFICATION.**

Under clause (1) of section 2 of the Chennai City Police (Extension to the Cities of Salem, Tiruchirappalli and Tirunelveli) Act, 1997 (Tamil Nadu Act 51 of 1997), the Governor of Tamil Nadu hereby makes the following amendment to the Home Department Notification No. II(2)/HO/347(a-2)/2014, published at pages 1-2 in Part II-Section 2

of the *Tamil Nadu Government Gazette Extraordinary*, dated the 5<sup>th</sup> June 2014:-
