### ORDER:

The Registrar General, High Court of Madras, in his letter read above, has stated that the High Court, after considering the request of the Thiruvottiyur Advocates Association and also in consultation with the Principal District Judge, Tiruvallur recommends the proposal for constitution of a Sub Court at Thiruvottiyur in Tiruvallur District. In this regard, he has stated that out of the 6118 cases pending on the file of the existing Sub Court, Ponneri as on 31.10.2019, 2428 cases including 491 Original Suits, 134 Appeal Suits and 91 Session Cases are arising from the territorial jurisdiction of the proposed Sub Court at Thiruvottiyur. The number of 491 Original Suits arising from the territorial jurisdiction of Thiruvottiyur justify the necessity for the constitution of a Sub Court at Thiruvottiyur in Tiruvallur District.

2. The Registrar General, High Court of Madras has, therefore, requested the Government to issue orders for constitution of a Sub Court at Thiruvottiyur in Tiruvallur District with requisite posts and other requirements. He has also requested the Government for the attachment of the Copyist Establishment and Nazir Establishment now functioning at the District Munsif Court, Thiruvottiyur with that of the proposed Sub Court, Thiruvottiyur to form a Central Nazerath Establishment and Central Copyist Establishment, on the constitution of a Sub Court at Thiruvottiyur.

3. During the Budget Session of the Tamil Nadu Legislative Assembly for the year 2020-2021, the Hon'ble Minister for Law, Courts and Prisons, while moving the Demand for Grants relating to Administration of Justice (Demand No.3) has made, among others, the following Announcement on the Floor of the Assembly on 20.3.2020:-

“Constitution of a Sub Court at Thiruvottiyur in Tiruvallur District”

4. The Government, after careful examination of the proposal of the Registrar General, High Court of Madras have decided to accept it. Accordingly, the Government order for constitution of a Sub Court at Thiruvottiyur in Tiruvallur District at a total expenditure of Rs.1,55,16,336/- (Rupees one crore fifty five lakh sixteen thousand three hundred and thirty six only) (i.e. Rs.1,37,97,836/- as recurring expenditure and Rs.17,18,500/- as non-recurring expenditure) by sanctioning the following posts and other infrastructure facilities.

6. The Director of Stationery and Printing, Chennai is directed to supply one Tamil Typewriter and one English Typewriter, stationery articles, requisite forms and registers to the above said court at free of cost against the specific indent of the Judicial officer concerned.

7. The Registrar General, High Court of Madras is requested to send necessary draft notifications to the Government for its publication in the Tamil Nadu Government Gazette, under the provisions of the Tamil Nadu Civil Courts Act, 1873 [Central Act III of 1873] for the commencement of the above said court and also to send the draft Notification under first proviso to section 13 of the said Act to be published by the High Court, for approval of the Government.

Orders for sanction of an advance from the contingency fund will be issued by the Finance (BG-I) Department. The Registrar General, High Court is also requested to send necessary explanatory notes for inclusion of this expenditure in the Supplementary Estimates for the year 2020-2021 at the appropriate time without fail.


