ORDER:

In the Government order first read above, the Government had permitted to share the documents pertaining to road accident case with insurance companies to expedite settlement of claims to the victims and also directed the Director General of Police to collect a sum of Rs.100/- per document related to road accident cases. The collected amount was deposited in the Crime and Criminal Tracking Network Systems service fund head of account.

2. In the letter second read above, the Director General of Police has stated that during the decentralized budget meeting held on 27.10.2021, the Deputy Secretary to Government (Budget) has instructed to send the proposals for revision of existing Government fee for the documents requested by the Insurance Companies such as FIR, Vehicle registration etc. Accordingly, the Director General of Police has sent a proposal in which he informed that the Crime and Criminal Tracking Network Systems citizen portal (<https://eservices.tnpolice.gov.in>) was launched by the Hon'ble Chief Minister on 13.03.2013 and many online services are being offered to the citizens like online registration of complaints and viewing the status of FIR, CSR etc.. and the Additional Director General of Police, State Crime Records Bureau, Chennai has sent the proposal requesting for an increase of 25% (i.e. Rs.125/- per document) from the existing rate collected from

the Insurance Companies for downloading the documents related to road accident case.

3. The Director General of Police has therefore requested the Government for an increase of 25% (i.e. Rs.125/- per document) from the existing rate collected from the Insurance Companies for downloading road accident case documents.

4. After careful examination, the Government have decided to accept the proposal of the Director General of Police, Tamil Nadu and to increase the 25% (i.e. Rs.125/- per document) from the existing rate of Rs.100/- collected from the Insurance Companies for downloading road accident documents. The receipts should be apportioned at the same ratio in accordance with the instruction in G.O.(Ms) No.353, Home (Modern) Department, dated 11.04.2017. Out of Rs.125, a sum of Rs.12 and 50 paise to be deposited to Government account and Rs.112 and 50 paise to Crime and Criminal Tracking Network Systems Services Fund.

5. This order is issued with the concurrence of the Finance Department vide its U.O. No.4868/Home-I/2023, dated 26.12.2023.
