In the G.O. 1st read above, the Government have revised the rates of admission as specified below:-

2. The Tamil Film Producers Council and the Tamil Nadu Cinema Theatre Owners' Federation Chennai in their representations 2nd and 3rd read above have requested to revise the rates of admission as detailed below:-

3. The Government have carefully examined the proposal put-forth by the Tamil Film Producers Council and the Tamil Nadu Cinema Theatre Owners' Federation, Chennai. It is a fact that several Town Panchayats which adjoin Corporation and Municipal areas have attained almost all the characteristics of the larger Urban agglomerations and in practical terms, there is hardly any distinction between these entities. It is therefore felt that it would be logical to club Corporations, Municipalities and Town Panchayats as a cluster, to decide the rates of admission, to Cinema theatres in these locations.

4. As far as Village Panchayats are concerned, a conscious decision has been taken to rationalize the rates in line with the actual conditions on ground. Moreover, the cost of running these establishments along with the maintenance aspects and the provision of facilities were also factored in before arriving at the rates of admission in these areas.

5. In the circumstances stated above, the Government have considered that the rates of admission need further revision. Hence the Government have decided to accept the request of Tamil Film Producers Council and the Tamil Nadu Cinema Theatre Owners' Federation, also to revise the rates of admission to the cinema theatres in Tamil Nadu.

6. Accordingly, in supersession of the orders already issued in the G.O. 1st read above, the Government direct that the rates of admission to the theatres in Tamil Nadu be revised as specified below:-

7. The Cinema theatre licensees shall make an application to the Licensing Authority concerned with "C" form licence for making necessary entry/endorsement for revision in rates of admission. The Licensing Authority shall return the "C" form licence with necessary entries.

8. Necessary amendments to the Tamil Nadu Cinemas (Regulation) Rules, 1957 will be issued separately.

9. The Additional Chief Secretary/Commissioner of Land Administration is requested to send necessary draft amendments to the Tamil Nadu Cinemas (Regulation) Rules, 1957.
