ORDER

In the Government order first read above, orders were issued, among others, for sanction of a District Munsif-cum-Judicial Magistrate Court at Anaicut in Vellore District with posts and other requirements.

2. Consequent to the above orders, the Registrar-General, High Court of Madras, has now sent draft notification under section 11 (1) of the Code of the Criminal Procedure, 1973 (Central Act 2 of 1974) for the purpose of establishment of a court of Judicial Magistrate at Anaicut in Vellore District, with a request to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the following Notification shall be published in the TamilNadu Government Gazette:-

In exercise of the powers conferred by sub-section (1) of section 11 of the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Governor of Tamil Nadu, after consultation with the High Court, Madras, hereby establishes a Court of Judicial Magistrate at Anaicut in Vellore District.
