ORDER:-

In the Government Order first read above, orders were issued for Constitution of 13 Family Courts including the Nilgiris at Udthagamandalam and notified in Government Order second read above. The Family Court, Udthagamandalam started functioning with effect from 01.11.2014. The said court exercises jurisdiction over the Udthagamandalam Town inclusive of Udthagamandalam Taluk as per Government Order second read above.

2. The Registrar General, High Court, Madras in his letter third read above has stated that the District Judge-cum-Chief Judicial Magistrate, the Nilgiris at Udthagamandalam has requested to extend the jurisdiction of Family Court, Udthagamandalam to the Kundha Taluk. As such, he has requested to issue necessary orders thereon and to publish the same in the Tamil Nadu Government Gazette.

3. The Government after careful examination have decided to accept the proposal of the Registrar General, High Court of Madras. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette.

NOTIFICATION

In exercise of the powers conferred by sub-section (2) of section 3 of the Family Court Act, 1984 (Central Act 66 of 1984), the Governor of Tamil Nadu, after consultation with the High Court of Madras, hereby expands the jurisdiction of the Family Court at Udhagamandalam to the local limits of Kundha Taluk also
