### **ORDER:-**

In the Government Order first read above, orders were issued for administrative sanction for constitution of 15 Family courts in four phases and also accorded financial sanction towards the constitution of four Family Courts including Kanniyakumari District at Nagercoil in 2016-2017 for phase-I and notified in the Government Order second read above. Subsequently, the necessary amendments were issued to Government order 2<sup>nd</sup> read above in the Government order third and fourth read above.

2. In the connection, the Registrar General, High Court, Madras has requested to issue necessary orders for extending the jurisdiction of the Family Court, Nagercoil for entire Kanniyakumari District.

3. The Government after careful examination have decided to accept the proposal of the Registrar General, High Court of Madras. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

**NOTIFICATION**

In exercise of the powers conferred by clause (b) of sub-section (1) read with sub-section (2) of section 3 of the Family Courts Act, 1984 (Central Act 66 of 1984), the Governor of Tamil Nadu, after consultation with the High Court of Madras, hereby makes the following amendment to Home Department Notification No.II(2)/HO/295(a-3)/2017 published at page 2 of Part II – Section 2 of the Tamil Nadu Government Gazette Extraordinary, dated 21<sup>st</sup> April, 2017, as subsequently amended, namely:-

**AMENDMENT**

In the said Notification, for the expression "the Agastheeswaram Taluk inclusive of Nagercoil Town and to the local limits of Kalkulam and Vilavancode Taluks", the expression "entire Kanniyakumari District" shall be substituted.
