

ABSTRACT

Tamil Nadu Cinemas (Regulation) Rules, 1957 – Revise the parking fees for all the Cinema Theatres - Amendment to rule – Orders – Notification - Issued.

ORDER:

In the G.O. 1st read above, Notification fixing the parking fees to regulate the collection of fees for parking vehicles in the premises of the cinema theatres was issued by incorporating Rule 91-B in the Tamil Nadu Cinemas (Regulation) Rules, 1957, since many complaints were received from the public that the licensees of Cinema theatres were collecting exorbitant fees for parking vehicles like cycles, scooters and cars in the premises of the Cinema Theatres. As per the Rule 91-B of said rules.

The licensee of the cinema theatre may collect a fee for parking vehicles in the premises of the cinema theatre specified in the Table below:-

- 2. The Licensee of Rohini Movie Park, Chennai and other licence holders of the Cinema Theatres Challenged the above said Rule in W.P.No.10048/1999 etc., before the Hon'ble High Court of Madras. The Hon'ble Single Judge struck down the above said rule.
- 3. The Government filed Writ Appeals (No.47 to 56 and 824 to 827 of 2002 batch) against above said High Court order before the Division Bench of Madras High Court. The Hon'ble Division Bench in its order 2^{nd} read above, dated 17.08.2010, set aside the order of Single Judge and allowed the Writ Appeals with the following directions:-

"However, at this distant of time, the Government cannot insist upon the same rates which have now become obsolete. The Government shall re-fix the parking fee after hearing the objections of the theatre owners and also the licensing authorities/District Collectors and re-fix the parking fee in accordance with law".

Challenging the above High Court order the licensee, Rohini Movie Park filed a Special Leave Petition (No.22158/2011) before the Hon'ble Supreme Court of India and the same was dismissed vide the Supreme Court of India order, dated 09.07.2013 as withdrawn.

4. As per the above orders of the High Court of Madras the Additional Chief Secretary to Government, Home, Prohibition & Excise Department called all the parties concerned (Writ Petitioners, President of Tamil Nadu Cinema Theatres Owners Federation and

- Thiru. K. Kathimathiyon, Coimbatore consumer cause) for personal hearing on 14.07.2017 and they submitted their written statements also. The Additional Chief Secretary/Commissioner of Land Administration also sent his report and the reports from the District Collectors.
- 5. In the reference 3rd read above, the Tamil Nadu Cinema Theatre Owners Federation, Chennai indicated parking fees collected in various public places and stated that about 324 sq.ft is required for parking a vehicle and they are paying an average pay of Rs.10,000/- as salary per month to 20 persons to take care of the parking space. They have, therefore, requested to fix the rates taking into account the above facts.
- 6. In the reference 4th read above, Thiru. K. Kathirmathiyon, Coimbatore Consumer Cause contended that as per condition No.16 of "C" form licence of Tamil Nadu Cinemas (Regulation) Rules, 1957 it is the duty of the licensee to provide sufficient parking space and make necessary arrangement to look after the vehicles parked. Hence, as per the above licence condition there is no provision to collect parking fees at cinema theatres. He has further stated that as the consumers could use parking space only for 2 hours and for 4 shows the theatres could collect amount from four consumers. Hence, he has suggested that 200% increase is quite reasonable and the parking fee for any category should not be more than 10% of the ticket rates.
- 7. In the reference 5th read above, the Additional Chief Secretary/ Commissioner of Land Administration, Chennai has recommended that average fee, which could be considered for fixation of fee for parking vehicles in the premises of cinema theatre arrived at as follows:-

He has further stated that in respect of Greater Chennai Corporation area, Rs.15/- for Two-Wheelers and Rs.30/- for Three/Four Wheelers may be considered, since, operational cost will be higher in Chennai.

8. The Government have examined the above suggestions of the stake holders, the Additional Chief Secretary/Commissioner of Land Administration and the licensing authorities in detail and decided to revise the parking fees for all the Cinema Theatres (including Multiplex Theatres) in the State of Tamil Nadu as given below. Accordingly, the Government

order that the parking fees for all the Cinema theatres including multiplex theatre in the State of Tamil Nadu be revised as given below:-
