ORDER

In the Government order first read above, orders were issued for constitution of a Subordinate Judge's Court at Kodumudi in Erode District with posts and other requirements.

2. Pursuant to this, the Registrar-General, High Court of Madras, has forwarded draft notifications under sections 4, 5 and 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873) for the purpose of constitution of a Subordinate Judge's Court at Kodumudi in Erode District with a request to publish the same in the Tamil Nadu Government Gazette.

3. The Government, after careful examination of the proposal of the Registrar-General, High Court of Madras, have decided to accept it. Accordingly, the following Notifications shall be published in the Tamil Nadu Government Gazette:-

NOTIFICATION - I

In exercise of the powers conferred by the first paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, hereby alters the number of Subordinate Judges

to be appointed under the said Act for Erode District as nine with effect from the date on which the Subordinate Judge, Kodumudi assumes charge of that Court.

NOTIFICATION-II.

In exercise of the powers conferred by the second paragraph of section 4 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu, after consultation with the High Court, Madras hereby fixes the number of Subordinate Judges to be appointed for the Subordinate Judge's Court at Kodumudi in Erode District as one with effect from the date on which the Subordinate Judge, Kodumudi assumes charge of that Court.

NOTIFICATION - III.

In exercise of the powers conferred by section 5 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu hereby fixes Kodumudi in Erode District as the place at which the Subordinate Judge's Court, Kodumudi shall be held.

NOTIFICATION - IV.

In exercise of the powers conferred by section 10 of the Tamil Nadu Civil Courts Act, 1873 (Central Act III of 1873), the Governor of Tamil Nadu hereby directs that in the District of Erode, the Principal Subordinate Judge's Court at Erode shall cease to have jurisdiction over the District Munsif Court, Kodumudi and hereby fixes the local limits of the District Munsif Court, Kodumudi as the local limits of jurisdiction of the Subordinate Judge's Court at Kodumudi with effect from the date on which the Subordinate Judge, Kodumudi assumes charge of that Court.


