ORDER:

The Hon'ble Chief Minister, on the floor of the Legislative Assembly during the Budget Session for the year 2022-2023 in respect of the Forensic Sciences Department, among other things, has made the following announcement:

“புதியதாக உருவாக்கப்பட்டுள்ள தாம்பரம் மற்றும் ஆவடி காவல் ஆணையரகங்களுக்கு இரண்டு புதிய இயங்கும் தடய அறிவியல் ஆய்வகங்கள் ரூபாய் 107 கோடி செலவில் உருவாக்கப்படும்”

2. In the Government Order, first read above, pursuant to the above announcement and based on the proposal of the Director(i/c), Forensic Sciences Department, Chennai, the Government accorded administrative sanction for a sum of Rs.1,05,28,650/- [i.e., Rs.24,39,325/- as recurring expenditure per Mobile Forensic Science Laboratory and Rs.28,25,000/- as non-recurring expenditure per Mobile Forensic Science Laboratory] towards creation of Two (2) Mobile Forensic Science Laboratories [MFSLs] each one to the Tambaram and Avadi Police Commissionerates as detailed below:

3. The Director(i/c), Forensic Sciences Department, Chennai, in his letter second read above, has stated that the bidder viz., Kwick Soft Solutions Pvt. Ltd., who has been selected after due Tender process and further price negotiations by the purchase committee, offered to supply specially designed MFSL vehicle at a cost of Rs.31,60,000/- per vehicle [i.e., basic price of Rs.26,77,966/- + 2,41,017/- (SGST) + 2,41,017/- (CGST)]. The Director(i/c), Forensic Sciences Department, Chennai has also stated that a separate proposal will be submitted to the Government for according financial sanction for staff and purchase of furniture, after issue of order for purchase of vehicles. The Director(i/c), Forensic Sciences Department, Chennai has requested to accord financial sanction for a sum of Rs.69,20,000/- towards purchase of 2 specially designed MFSL vehicles and for Fuels & Consumables [i.e. Rs.63,20,000 (Non-Recurring) for purchase of 2 Vehicles at a unit cost of Rs.31,60,000; and, Rs.6,00,000/ (Recurring) towards Fuels and Consumables for 2 vehicles] instead of administrative sanction of Rs.61.00 lakh accorded in the Government Order first read above.

4. The Government have examined the proposal of the Director(i/c), Forensic Sciences Department, Chennai and decided to accept the same. Accordingly, accord revised administrative sanction for a sum of Rs.1,13,48,650/- (i.e., Rs.8,20,000/- over and above the administrative sanctioned amount of Rs.1,05,28,650/-) and financial sanction for a sum of Rs.63,20,000/- for purchase of two (2) specially designed MFSL vehicle, towards creation of two (2) Mobile Forensic Science Laboratories each one to newly formed Commissionerates at Avadi and Tambaram.

5. The expenditure sanctioned at para-4 above shall be debited to the following head of account:-

6. The Director(i/c), Forensic Sciences Department, Chennai is directed to follow the existing tender and purchase procedures as per rules in force, wherever necessary. The Director (i/c), Forensic Sciences Department, Chennai is authorized to incur the expenditure sanctioned above.
