Sub: The Right to Information Act, 2005 – Separate Head of Account for the payment of penalty imposed on Public Information Officers – Opening – Regarding.

2. Letter No.8184-C/AD/2020-1, dated 15.07.2020 received from the Additional Chief Secretary / Director and Director General of Training, Anna Institute of Management (now called as Anna Administrative Staff College).

I am directed to state that in the reference 1st cited, the Government have notified the Tamil Nadu Right to Information (Fees) Rules, 2005.

2. Account heads for collection of fees, refund of fees, and for making payment to the petitioner as compensation by the Public Authority under section 19(8) of the Right to Information Act have been opened. However, no head of account has been opened for the recovery of Penalty imposed on the Public Information Officer for their non-compliance of the provision of the Right to Information Act, under section 20(1).

3. The Government have examined the matter and have decided to open a new head of account for the recovery of penalty imposed on the Public Information Officer by the Tamil Nadu Information Commission, for their non-compliance of the provisions of the Right to Information Act, under section 20(1).

4. The following is the new Head of Account for the recovery of Penalty from the Public Information Officer under the Right to Information Act.




