ORDER:

In the Government Order read above, among others, the Tamil Nadu Power Finance and Infrastructure Development Corporation Limited (TNPFC) and Tamil Nadu Transport Development Finance Corporation Limited (TDFC), which were hitherto functioning under the Energy and Transport Department respectively, have been brought under the Finance department.

2. Therefore, in exercise of the powers conferred by Clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Business Rules, 1978.

AMENDMENT.

In the said Rules, in the "FIRST SCHEDULE",

(1) under the heading "TRANSPORT DEPARTMENT", under the sub-heading "State Subjects", for the entry "Transport including Transport Development Finance Corporation, Institute of Roads Transport and Transport Engineering Corporation", the entry "Transport including Institute of Roads Transport and Transport Engineering Corporation" shall be substituted:

(2) under the heading "FINANCE DEPARTMENT", under the sub-heading "State Subjects", after the entry "Supplementary, additional or excess grants and Statements of expenditure", the following entry shall be inserted, namely:-

P.T.O.,

"Tamil Nadu Power Finance and Infrastructure Development Corporation Limited (TNPFC) and Tamil Nadu Transport Development Finance Corporation Limited (TDFC)".


