In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Business Rules, 1978, namely:-

AMENDMENTS.

In the said Rules, in Part I, in the “FIRST SCHEDULE”,-

- (1) under the heading “WELFARE OF DIFFERENTLY ABLED PERSONS DEPARTMENT”, under the sub-heading “State Subjects” for the entry “Welfare and rehabilitation of leprosy beggars – Prevention of Begging Act – Care of beggars – Welfare and rehabilitation of mentally challenged Children – Welfare and rehabilitation of differently abled children” the entry “Welfare and rehabilitation of mentally challenged Children – Welfare and rehabilitation of differently abled children” shall be substituted;

- (2) under the heading "SOCIAL WELFARE AND WOMEN EMPOWERMENT DEPARTMENT", under the sub-heading "State Subjects", before the entry "Care of old and infirm persons", the entry "Beggary, The Tamil Nadu Prevention of Begging Act, 1945 and Care of beggars" shall be inserted.
