ORDER:

In the Government Order 2nd read above, a new Department called "Natural Resources Department" has been created in the Secretariat with re-allocation of certain subjects.

2. In exercise of the powers conferred by clauses (2) and (3) of Article 166 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Government Business Rules, 1978 and the Secretariat Instructions:-

AMENDMENTS

In the said Rules, in Part –I, in the FIRST SCHEDULE,-

(1) under the heading "AGRICULTURE AND FARMERS' WELFARE DEPARTMENT",-

(a) under the sub-heading "State Subjects", -

(i) after the entry "Commercial Crops", the entry "Commissioner of Sugar" shall be inserted;

- (ii) after the entry "Tamil Nadu State Farms Corporation", the entry "Tamil Nadu Sugar Corporation Limited" shall be inserted;
 - (b) under the sub-heading "Union Subjects", after the entry "Meteorology – Union Organisation", the entry "Sugar Industry" shall be added;
- (2) under the heading "INDUSTRIES DEPARTMENT", -
- (a) under the sub-heading "State Subjects", the following entries shall be omitted, namely:-
 - "Commissioner of Geology and Mining";
 - "Commissioner of Sugar";
 - "Tamil Nadu Minerals Limited";
 - "Tamil Nadu Magnesite Limited";
 - "Tamil Nadu Magnesium and Marine Chemicals Limited";
 - "Mines and oil fields and development of Minerals Resources";
 - "Taxes on Mineral rights"; and
 - "Tamil Nadu Sugar Corporation Limited";
 - (b) under the sub-heading "Concurrent Subjects", the entry "Geological Survey" shall be omitted;
 - (c) under the sub-heading "Union Subjects",-
 - (i) the following entries shall be omitted, namely:-
 - "Sugar Industry.";
 - "Mines and oil fields and mineral development - Regulation to the extent to which such regulations and development under Union control is declared by the Union Law to be expedient in the Public interest and regulation of Labour and safety in mines and oil fields.";
 - (ii) before the entry "Capital issues and import trade", the entry "Air Craft and Air navigation, regulation and organisation of air traffic and of aerodromes" shall be inserted.;
- (3) under the heading "TRANSPORT DEPARTMENT", under the sub-heading "Union Subjects", the entry "Air Craft and Air navigation, regulation and organisation of air traffic and of aerodromes" shall be omitted.;

- (4) under the heading "PUBLIC DEPARTMENT", under the sub-heading "Concurrent Subjects", after the entry "News print control", the entry "Overseas Manpower" shall be inserted.;
- (5) after the heading "MUNICIPAL ADMINISTRATION AND WATER SUPPLY DEPARTMENT" and the entries relating thereto, the following heading and entries shall be inserted, namely:-

"NATURAL RESOURCES DEPARTMENT

State subjects-

Commissioner of Geology and Mining

Mines and Oil fields and development of Minerals Resources

Public Services - Statutory Rules of the Service with which the department is concerned – Revision of and amendments to those rules.

State Works and Buildings under the administrative control of this department.

Tamil Nadu Minerals Limited

Tamil Nadu Magnesite Limited

Tamil Nadu Magnesium and Marine Chemicals Limited

Taxes on Mineral rights

Concurrent Subjects-

Geological Survey

Union Subjects-

Mines and oil fields and mineral development –

Regulation to the extent to which such regulations and development under Union control is declared by the Union Law to be expedient in the public interest and regulation of Labour and safety in mines and oil fields".
