- (ii) under the heading "INDUSTRIES, INVESTMENT PROMOTION AND COMMERCE DEPARTMENT", as so substituted, under the sub-heading "State Subjects", for the entry "Tamil Nadu Industrial Guidance and Export Promotion Bureau" the entry "Guidance" shall be substituted;

(2) in Part II, in the Secretariat Instructions, for the entry "Industries Department", wherever it occurs, the entry "Industries, Investment Promotion and Commerce Department" shall be substituted.
