ORDER:

Tamil Nadu Public Service Commission (Additional Functions) Act, 2022, (Tamil Nadu Act 14 of 2022) has been enacted and notified in the Tamil Nadu Government Gazette Extra Ordinary read above.

2. Accordingly, the Government brings into force the said Act and frames the Rules, thereunder. The following Notifications will be published in the Tamil Nadu Government Gazette Extra Ordinary:-

NOTIFICATION - I

In exercise of the powers conferred by sub-section (2) section 1 of the Tamil Nadu Public Service Commission (Additional Functions) Act, 2022 (Tamil Nadu Act 14 of 2022), the Governor of Tamil Nadu hereby appoints the 17th day of March 2022 as the date on which the said Act shall come into force.

NOTIFICATION - II

In exercise of the powers conferred by section 7 of the Tamil Nadu Public Service Commission (Additional Functions) Act, 2022, (Tamil Nadu Act 14 of 2022), the Governor of Tamil Nadu hereby makes the following Rules, namely:-

RULES

1. **Short title.**- These Rules may be called the Tamil Nadu Public Service Commission (Additional Functions) Rules, 2022

(P.T.O.)

2. **Definitions.-** (1) In these Rules, unless the context otherwise requires, -
(a) "Act " means the Tamil Nadu Public Service Commission (Additional Functions) Act, 2022 (Tamil Nadu Act 14 of 2022);
(b) "Form" means a Form appended to these rules;
(2) Words and expressions used in these Rules, but not defined, shall have the meaning assigned to them in the Act.
3. **Form of Requisition.-** An organization, for recruitment of candidates for appointment to posts in that organisation, shall submit requisition to the Commission in Form A along with the 'Estimate of Vacancies', as prepared in Form B.
