#### ORDER:

In pursuance to the orders issued in the Government Order second read above, the following notification will be published in the <u>Tamil Nadu Government</u> <u>Gazette:-</u>

### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 read with Article 313 of the Constitution of India and of all other powers hereunto enabling, the Governor of Tamil Nadu hereby makes the following amendments to the Fundamental Rules and the Instructions thereunder.

2. The Amendments hereby made shall be deemed to have come into force on the 1<sup>st</sup> July 2021.

AMENDMENTS.

In the said Fundamental Rules, in rule 101, under the heading "Instructions under Rule 101 (a) – Maternity Leave.", in instruction 1.-

(1) for the expression "270 days", wherever it occurs, the expression "365 days" shall be substituted;

(2) for Explanation 3, the following Explanation shall be substituted, namely:-

"Explanation 3.- The women Government servants who proceeded on maternity leave prior to 1<sup>st</sup> July 2021 and continued to be on that leave on or after that date shall also be eligible for maternity leave for a period not exceeding 365 days in total."
