ORDER:

In the Inspection Report on the accounts of the Tamil Nadu Information Commission sent along with the letter read above, in Para B16/2018, the Accountant General has observed that the Tamil Nadu Information Commission was constituted in 2005 under the powers vested in Section 15(1) of the Right to Information Act 2005 and that the Commission exercises the powers conferred on it and performs the function assigned to it under this Act. He has also observed that since the inception of the Commission, no internal audit has been conducted. Therefore, he has advised to take action for the conduct of Internal Audit in the Tamil Nadu Information Commission under intimation to Audit.

2. The Government, after carefully examining the observations of the Accountant General, have decided to entrust the Internal audit of the Tamil Nadu Information Commission to the Director, State Government Audit Department, Nandanam, Chennai 600 035.

3. Accordingly, the Government directs that periodical Internal Audit of the Tamil Nadu Information Commission may be conducted by the Director, State Government Audit Department, Nandanam, Chennai 600 035.
