**NOTIFICATION.**

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Chinnamanur Local Planning Area, which has been declared as such vide the Housing and Urban Development Department Notification No.II(2)/HOU/2010/85, published at page 316 of Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 24<sup>th</sup> April 1985, namely:-
