- 4. The Government, after careful consideration of the above proposal of the Director of Town and Country Planning have decided to declare their intention to include the additional areas in Chinnamanur Local Planning Area under clause (b) of sub-section (1) of section 10 of the said Act.

- 6. The Collector of Theni District is directed to republish the Notification in the <u>District Gazette</u>.
- 7. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Collector of Theni District under intimation to the Government.
- 8. The Collector of Theni District is directed to report to Government the date of republication of the notification in the <u>District Gazette</u>.

APPENDIX. NOTIFICATION.

In exercise of the powers conferred by clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby declares his intention to add the areas of the following revenue villages to the Chinnamanur Local Planning Area, which has been declared as such vide the Housing and Urban Development Department Notification No.II(2)/HOU/2010/85, published at page 316 of Part II–Section 2 of the Tamil Nadu Government Gazette, dated the 24th April 1985, namely:-
